## **AGENDA**

POLICY (Dr. Stoker)

- Policy 202.1 <u>Foreign Exchange Students</u>
  - This policy was brought before the Education Committee at the last committee meeting in August for discussion about whether or not we wanted to have a fall deadline and a separate spring enrollment deadline.
    The committee decided we did.
  - This policy was updated to include a November 1st enrollment deadline for foreign exchange students for the spring semester.
  - Committee supports the policy going to the Board for first reading

- Policy 220 Student Expression / Dissemination of Materials
  - Policy 220 is recommended for legal liability purposes.
  - Title of policy changed from Student Expression/Distribution and Posting of Materials to Student Expression / Dissemination of Materials.
  - Definition of dissemination now includes both distribution and posting.
  - Policy was revised to more clearly outline instances of student expression that would be subject to the limitations, prohibitions and requirements of the policy. (See page 4, #1-3)

New language was incorporated into the policy regarding the training of staff involved in reviewing requests for dissemination of nonschool materials to ensure understanding of evaluation processes of such requests as well as the limitations on school officials' authority to regulate off-campus student expression.

- Committee supports the policy going to the Board for first reading
- Policy 913 Nonschool Organizations / Groups / Individuals
  - Policy 913 is recommended for legal liability purposes.
  - Policy 913 only applies to requests from nonschool organizations, groups and individuals
  - The terms "distribution and posting" were changed to "dissemination" throughout
  - The definition of nonschool materials was expanded
  - The term "nicotine" was changed to "vaping products"
  - Updated the qualifier materially and substantially disrupt or interfere with the educational process
  - Reference to social media channels and the social media policy were added
  - Committee supports the policy going to the Board for first reading
