

## Frederick County Public Schools - Approved Comercial Carriers

Schools must require a completed Certification of Contractor form from the carrier prior to scheduling a trip. (Note: this form indicates that none of the persons who will provide services requiring direct contact with students have been convicted of a felony or any offenses involving the sexual molestation, physical or sexual abuse or rape of a child.) Schools must also obtain a Certificate of Insurance from the carrier that is current and does not expire prior to the end of the trip.

Competition is required if cost of the chartered services will exceed \$5,000.00. For services costing between \$5,000.01 and \$30,000.00, three (3) quotes must be obtained and for services costing between \$30,000.01 and \$200,000.00, four (4) quotes must be obtained. Please refer to section 10.12, Procuring Charter Bus Services, of the Purchasing Manual for additional information.
