Darien Public School Health Requirements FAQs for Families New to the District (rev.7.17.2024)

What health documentation is required for my child to be registered in the Darien Public Schools?

Every student entering the district will need a [Health Assessment Record](#) from a physical exam within the calendar year and an up-to-date state mandated **Immunization Record**. Please upload forms (pdf format) onto Family Connections or email to your child's [school nurse](#). Please understand, your child will not be enrolled until health documentation has been reviewed and verified by a school nurse in the district.

What if I am moving from within the United States?

We understand that families new to the Darien community may not have a local health care provider. Please make an appointment as soon as possible ([click here](#)). To register your child(s) into DPS, please upload a pdf version of the most recent health assessment and immunization record on Family Connections or email a copy directly to your child(s) [school nurse](#). School nurses will review the documentation and notify you with missing or noncompliant health documentation.

What if I am moving from outside the United States?

We understand that families new to the Darien community may not have a local health care provider. Please make an appointment as soon as possible ([click here](#)). To register your child(s) into DPS, please upload a pdf version of the most recent health assessment and immunization record on Family Connections or email a copy directly to your child(s) [school nurse](#). School nurses will review the documentation and notify you with missing or noncompliant health documentation. Given you are from outside of the United States, your child may require additional services such as translation, vaccines and/or a health assessment performed by a medical provider licensed in the United States. Nurses will communicate with you directly on what your child will need to be compliant and steps you can take to meet the requirements.

What if my child(s) documentation does not meet the state mandated health requirements?

There are many local clinics, who have quick (often same day) appointments and can provide your child with the necessary translation, vaccines and/or health assessments (see list below). We encourage you to still make an appointment as soon as possible with a local pediatrician ([click here](#)).

- **American Family Care Clinics**: Provides physical exams and vaccinations required for school physicals. You may make an appointment online but it is not necessary. AFCs accept most insurance carriers and a majority of new affordable care act insurance plans

- **CVS Minute Clinic**: Provides physical exams and vaccinations for school physicals. You may make an appointment online or just walk in. CVS accepts most insurance carriers.

- **Community Health Center:** Provides pediatric medical, behavioral and dental care including physical assessments and vaccinations. CHC provides care to uninsured individuals as well as those with public health insurance, such as HUSKY. CHC has an “access to care” team to help families apply for public health insurance programs. Patients who are not eligible can receive care at a reduced rate through our sliding scale fees. [CHC website](#)

- **Norwalk Community Health Center:** Provides eligibility and translation services through an initial information gathering appointment. At that time, NCHC staff assist families by helping to make appointments and explaining required documentation.

- **Norwalk Health Department:** Provides eligibility, translation and vaccination services. Be sure to bring all of your current health documentation to the first appointment.

- **Greenwich Hospital and Department of Health:** - Greenwich Hospital Clinic is merging with Family Centers, a program under the Department of Health. They accept new patients but they *must be uninsured and can be undocumented*. Services provided include school physical assessments, tests and screenings. [Greenwich Family Health](#)

Will my child be able to register and start at DPS without meeting the Health requirements?

Unfortunately, unless your child falls under the McKinney Vento act (see below) state law (C.G.S. Secs. 10-204a and 10-206) requires complete primary immunizations and a health assessment by a legally qualified health provider prior to school entrance. Your child will not be registered into DPS without having met these requirements.

Who can I contact with any questions regarding registration and meeting the health documentation requirements?

What if my child's health documentation is in a different language?

Translation services are available at Norwalk Community Health Centers. Call to set up an initial appointment and be sure to bring with you health documentation that you have. [Norwalk CHC](#)

What if my child is determined to be “homeless” under the McKinney - Vento Act?

Students who wish to register school and are qualified as homeless children and youth under the McKinney - Vento Homeless Assistance Act will be enrolled immediately into the district. Health documentation is not required for enrollment.

What if my child has a religious exemption from another State?

Effective April 28, 2021, Connecticut no longer accepts any new religious exemptions. Students who transfer from schools within Connecticut and have a valid, completed Religious Exemption form in their

school health file prior to April 27, 2021 will be allowed to continue to have a Religious Exemption to immunizations. Children who transfer in from states other than Connecticut, or outside the United States after April 27, 2021 are not eligible for Religious Exemption to immunizations in Connecticut. Will my child require a Tuberculosis Skin Test prior to registration into DPS?

It is recommended that your practitioner assess your child for risk of exposure to Tuberculosis. Students originally from high Tuberculosis burden countries entering Connecticut schools for the first time, must receive a Tuberculosis Skin Test.
