Mr. Finnerty has been guiding us through updating our Counseling Plan to improve our program and align with the new state regulations for counseling plans, which go into effect July 1, 2019. This process has already been very beneficial and we are excited to create a plan to share with you at a later date.

All teachers will be looking at the assessment, collaboration, and engagement strategies that are used in the other classroom, as these strategies have been a focus for us this year.
