- 3. Communications of the Superintendent
- a. Mr. Gaffney introduced Robin Robinson, Administrator of the Initiatives and Grants R4K (Readiness for Kindergarten) Program from the United Way, to talk about the program.
- b. Mr. Gaffney introduced Tom Meiss to speak about the Oriskany Football program potentially combining with the Westmoreland Football program to form an eleven man football team.
- c. Mr. Gaffney also introduced 3 Government and Economics senior students to discuss their plans for next year.
 - 4. Communications of the School Business Administrator/District Clerk
- a. Budget material is being reviewed and meetings with district stakeholders will take place in early January. A meeting with faculty at each building will take place in mid January, as well, regarding purchasing for the 2019-2020 school year.
- b. Mrs. Widman has been working with Steve Davis, Scott Morris, Mike Carney and Jeff Morgan regarding the district technology replacement plan. They plan to apply for another Smart School Grant to assist with this 5 year plan.
- c. The second set of bus safety drills were completed this week and they went very well.
- d. All district buildings passed the safety inspection with 100 percent compliance, our Certificates of Occupancy are all set to go.

5. Communications of the Building Principals Elementary:

- a. 26 Pre-observation meetings, unannounced observations, and post-observation meetings, plus 3 extra for an untenured teacher who is on an improvement plan, will be completed by Winter Recess. They began October 17 due to the late roll-over of the NYS Growth Scores in My Learning Plan. Ms. Hinderling will have 2 more Pre-observation meetings, unannounced observations, and post-observation meetings for her two teachers returning from maternity leave in January. In the spring, she will be completing a third unannounced observation and post-observation meeting for her 7 untenured teachers along with 5 teacher assistant observations.
- b. On Sunday, December 9, the PTA had a Holiday Bingo, Craft, & Movie from 2:00-4:00 pm. Approximately 50 students attended the event.
- c. Instructional Focus Teams are meeting this week. The topics of the teams are: Community Involvement, Technology, Reading Strategies, and two groups focus

on Mental Health. The team members also took a survey on what topics they would like to focus on for the second half of the school year. At the February Professional Development Day the teams will be sharing out on what they discussed at their team meetings.

- d. On Thursday, December 20, we will be having our monthly otherpeoplematter assembly. Our Positivity Project focus words are social intelligence and hope. We will be sharing out of all the various organizations we have donated to including Rescue Mission, Magnanti Family, Stuff the Bus,
 - Rome Humane Society, Thea Bowman House and Scholastic Pajama Drive. The sixth grade is visiting the Eastern Star tomorrow and bringing gifts for the residents. They will also play games and complete a craft. In addition a few of the residents will be coming to our assembly. During the assembly we will also sing some holiday songs. At the conclusion of the assembly, the classroom partners will meet and complete a "2019 Goal Banner" which will be hung up in the cafeteria hall. They will also read together before heading back to their classrooms for small holiday celebrations.
- e. We would also like to thank the honor society volunteers for coming last week to help after their school day. I have been working with their advisor Lauren Valente to arrange more visits. We are also arranging the volunteers to help with a Book Drive that will begin next month.

High School:

- a. Ms. Thompson gave a shout out to the Band, Chorus, and Jazz Band for their performances at last week's Winter Concert.
- b. This week is Spirit Week at the Jr/Sr High School, organized by the P2 People! Today was Merry Monday, then we have Twinkly Tuesday, Winter Wonderland Wednesday, Festive Sweater Day on Thursday, and Pajama Day on Friday. Over the weekend, some P2 elves put notes of motivation and kindness on every student's locker to focus on our current trait of kindness, and added a candy cane to spread some holiday cheer! On Friday we will be hosting a free showing of The Polar Express after school free of charge. Hot chocolate and popcorn will also be provided. We are also holding drives and organizing holiday cards for the elderly as ways to show kindness and give back to the community.
- c. Tomorrow night is the gray-out for Team Magnanti. Winter athletes have adopted the family for Christmas and will be presenting them with presents in between the JV and Varsity games. A special thank you to Tom and Angela Meiss for organizing this event.
