4. Communications of the School Business Administrator/District Clerk
 - a. As Tim mentioned, opening day went well, students and teachers were happy to get back to school.
 - b. The Safety Committee Meeting is this Thursday at 3:30 and Facilities is this week Wednesday, at 3pm.

5. Communications of the Principals
 - Elementary:
 - a. Ms. Hinderling thanked faculty and staff at Walbran for a successful school opening.
 - b. It was a successful first day assembly to welcome the students back and to review the Walbran Way, show some of the new items around the school such as our new water fountains and the playground. The building "theme" this year is Life is An Adventure.
 - c. RTI groups that were formed during last June's Data meeting and Building IST meetings, began meeting this week.
 - d. Elementary has also started STAR Benchmark testing for grades first through sixth grade this week in STAR math and STAR reading. Students in grade PK and K will be tested in STAR Literacy later this month.
 - High School:
 - a. Ms. Thompson was attending Senior Parent Night and Financial Aid Night the Jr./Sr. High School.
 - b. School Opening has gone very well. Students are settling into their classes and their new routines.
 - c. Ms. Thompson met with all grade levels on Thursday to discuss changes in the handbook and expectations for student behavior.
 - d. A huge thank you to the faculty and staff for all their hard work in preparing school to open.
 - e. Back to school night was a success! Many students and parents attended orientations and the Open House portion of the evening. Many students were able to pick up their schedule and their chrombook prior to school starting. Combining all of these events into one night increased attendance of both students and parents, which we are excited about. Ms. Thompson is working with her Building Level Team to gather feedback and make any necessary changes to the program for next year.

7. Communications of the Director
 - a. Thank you to the building principals, SPED case managers, Kathie Higgins, and all instructional staff for successfully getting IEP, 504, and declassified services implemented for our students.
 - b. We are working closely with the newly BOCES appointed CSE/CPSE/504 Chairperson and New York Mills UFSD to ensure a smooth transition.
 - c. CSE/CPSE - We have three new referrals and will be starting evaluations soon.

- d. We have also had six new entrants with IEPs, and we are working to help students adjust to their new school.
 - e. AHS - We currently have 15 students enrolled in the Incarcerated Youth Program. This program is funded based on student enrollment.
 - f. ELL - We have three students in need of services from the BOCES ENL/ELL teachers. We are one of the schools that does have an ELL/ELL teacher in place. There is a significant shortage of English Language Learner teachers in our region.


