Driving and parking rules and regulations:

1. All automobiles parked on school grounds must be registered with the school. Once all information is obtained, please see the Main Office to acquire a parking pass. Students must place the pass on the driver side rear window so that it is visible from the outside. Your parking pass must be displayed at all times. If you change vehicles or use more than 1 vehicle, please see the Main office.
2. Students must park in the designated student parking areas or their pass can be revoked. There is absolutely no parking in teacher parking areas.
3. All unregistered vehicles, snowmobiles, dirt bikes and ATV's are prohibited on school grounds at all times. Unauthorized or illegally parked vehicles may be towed away at the owner's expense.
4. All students must be licensed and covered by insurance. Please keep vehicles locked and do not leave any valuables inside. The school is not responsible for the automobile or its contents, including damage, vandalism or theft of student vehicles.
5. There is no loitering in the parking lot or visitation without permission. There is also NO smoking/vaping in vehicles on school property. Failure to comply with this rule may result in disciplinary action, including revoking parking privileges.
6. The speed limit on school grounds is 5 miles per hour. Any form of speeding or reckless driving on school property will not be tolerated. It will result in driving and parking privileges being revoked.
7. No student vehicles are to leave school grounds while school is in session, unless permission has been granted by administration.
8. Parking regulations are strictly enforced. It is considered a privilege to park on school grounds. Suspension of privileges, towing of vehicles and/or suspension from school may occur when violations of these regulations occur.
- 9. Excessive tardiness or absences will result in riding/driving authorization being revoked.**
- 10. No student is permitted to bring another student to or from school unless authorized by the school administration.**
11. No vehicle may leave the parking area until all buses leave the school. Therefore, drivers and riders will not be dismissed from their last class until all of the buses leave.
12. These regulations are main areas of concern, but by no means are inclusive.
