

Southington Public Schools Green Cleaning Statement

Southington Public Schools, in compliance with the requirements of the State of Connecticut House Bill 6496 regarding green cleaning products in schools, is providing this information on the cleaning products used in our facilities. We have initiated a Green Cleaning Program which will be on-going. The intent of the green cleaning program is to reduce the exposure of the buildings occupants from potentially hazardous products, equipment or procedures which could adversely affect human health and the environment, indoors and outdoors.

The components of our Green Cleaning Program as required by CT. Bill 6496 include:

1. A Description and names of environmentally preferable cleaning products being used in the schools.
2. The location and application of where cleaning products are used.
3. The schedule or frequency of when such cleaning products are applied.
4. We will work towards eliminating and monitoring cleaning products being brought in from outside unauthorized sources as required by CT. Bill 6496 ("No parent, guardian, teacher or staff member may bring into the school facility any consumer product which is intended to clean, deodorize, sanitize or disinfect.")
5. The name of the designee who may be contacted for further information will be provided.

Southington Public Schools Dilution Control System for dispensing cleaning chemicals. Dilution Control Systems are placed in strategic and secured locations of each school. The systems are comprised of multiple dispensing options which allow flexibility, economy through accurate & consistent measurement of concentrated cleaners into RTU (Ready-To-Use) spray bottles, buckets, and/or cleaning equipment.
