13. (60 Min.) William C. Wade – CEO Update:

- Supplemental Marketing/Media Support YJ Media provided a summary on what they
 are able to provide for the school, a handout was provided to Board Members.
- Leader In Me Presentation (Linda Williams & Brandie Johnson) we are the only LIM school in the Pittsburgh area and they want us to become a model school for other schools looking to initiate LIM; provided take home materials for board members so that they can familiarize themselves with LIM.
- Cultural Awareness Committee Linda Williams provided an update of the first committee meeting, please see handout.
- Teacher Induction Presentation (Brandie Johnson) 14 new staff members are in the mentoring program. Regional trainings are available to staff for free.
- Seth: Suspensions we will not be one of those schools that suspends the students for minor infractions and the reflection room has been helpful in this regard; PBIS has been successful. Emergency go bags are now in classrooms for teachers to take with them in emergency situations.
- K-2 Data Presentation (Dr. Tyler Roberto)

 - 2. Enrollment K-2 94% 3 openings
 - 3. K-2 Attendance 99% of students come to school regularly
 - 4. Suspension data is down.
 - Successes- Roberto met privately with staff she oversees; new teacher observation process was initiated; lunch dismissal 2 hour delay protocol building communication to staff
 - 6. Challenges: behaviors; Mr. Cooks is providing services to families and will start to do home visits; lack of progress monitoring data; opening K and 1st for TA's and school counselor position;
 - 7. Good things A1 Schools handout: growth and achievement data compared to PPS; all of our students have grown in ELA and Math in some fashion from previous year:
 - 8. PPS School Audit: 2017-18 attendace rate 78% now we are at 96%; PPS audit was yesterday and they also toured our classrooms.
