PROPOSITION NO. 1 Budget

Shall the Board of Education of Medina Central School District of the towns of Ridgeway, Shelby, Barre and Albion, Orleans County, Hartland, Niagara County, and Alabama, Genesee County, New York, be authorized to make the expenditures of the monies set forth in the 36,620,794 proposed budget submitted to the Annual Meeting on May 9, 2017, and levy the necessary tax therefor?

PROPOSITION NO. 2

Reduce Board Members

Shall the Board of Education reduce the number of members sitting on its Board from nine (9) to seven (7), beginning in the 2018-2019 school year?

Section 2. The District Clerk is hereby authorized and directed to include within the notice of said annual meeting required to be published and posted by the District, a statement to the affect that the propositions set forth in Section 1 of the resolution will be voted upon at such annual meeting, which notice shall contain the full text of each such proposition.

And notice is also given that a copy of the statement of the amount of money which will be required for the ensuing year for school purposes, including public monies, may be obtained by any taxpayer in the district during the fourteen (14) days immediately preceding the Annual Meeting, except Saturday, Sunday, or holiday, at each of the following school houses in which school is maintained during the hours designated:

Clifford H. Wise Intermediate/Middle School - 9:00 a.m. to 4:00 p.m.
Oak Orchard Elementary School - 9:00 a.m. to 4:00 p.m.
Board of Education Office - 9:00 a.m. to 4:00 p.m.

ALSO TAKE NOTICE, that pursuant to Section 2018 of the Education Law, petitions for nominating candidates for the office of member of the Board of Education must be filed with the Clerk in the District Office of the Medina Central School District, One Mustang Drive, Medina, New York between the hours of 8 o'clock a.m. and 4 o'clock p.m., Prevailing Time, during any business day beginning February 17, 2017, but not later than 5 o'clock p.m. on April 17, 2017. The following vacancies are to be filled on the Board of Education as follows: **three (3) seats for terms of three years each.**

If the ballot is to be mailed to the voter, the completed application must be received by the Clerk of the District at least seven days before the day of the vote. If the ballot is to be issued personally to the voter, the completed application must be received by the District Clerk at least one day before the day of the vote. No absentee ballot shall be canvassed, unless it shall have been received in the office of the District Clerk no later than 5 o'clock p.m. (Prevailing Time) on the day of the election.
