Principal Sparby left the meeting at 7:30 p.m. for a 7-12 choir concert at the high school.

Business Manager Sander reported to the Board.

Principal Butler reported to the Board. Superintendent Sonju presented Principal Sparby's report.

Superintendent Sonju reported to the Board that administration is pursuing the STEM and STEAM initiatives and they recently traveled to Rochester and returned with great ideas; said they planned to meet with Rochester's coordinator on Thursday; reported they are considering how to implement STEM/STEAM into our elementary and junior high schools; told the Board he participated in the county water meeting last Friday and Director VonBerge was also present at that meeting; announced the Glencoe Chamber of Commerce recognized GSL for development of the new tennis courts; reminded Board members the Minnesota School Boards Association's Leadership Conference is scheduled for January 14th and 15th, and Board members are reminded to let Superintendent Sonju know of their availability so we can get them registered.

The school district held its annual Truth in Taxation Hearing at 6:00 p.m. Director Kuester moved to set the final 2015 levy payable 2016 at \$3,764,729.92. Director Lindeman seconded. Approved unanimously.

Kim Hillberg, our auditor from CliftonLarsonAllen, LLP, provided an overview of the audit summary and financial statements for the school district for the 2014-2015 school year at the October 12th Board meeting. Director VonBerge moved to accept the audit summary and financial statements for the 2014-2015 school year as prepared by CliftonLarsonAllen, LLP. Director Twiss seconded. Approved unanimously.

Director VonBerge moved to approve a three-year contract with Business Manager Sander from July 1, 2016, through June 30, 2019. Director Kuester seconded. Approved unanimously.

FFA Member Siewert left the meeting at 8:26 p.m.

Director Twiss moved to approve hiring a Bus Rider Supervisor on Bus 44 because of a student's need for up to five hours a week. Director VonBerge seconded. Approved unanimously.

Director Kuester moved to approve hiring a 6.75-hour-a-day Paraprofessional in Special Education at GSL High School to assist the Special Education team there. Director Lindeman seconded. Approved unanimously.

Director VonBerge moved to approve adding two summer courses to the agriculture department: "Summer Agriculture" and "Advanced Summer Agriculture." Becky Haddad, Ag Teacher and FFA Advisor, currently has 10 days for summer work and the request is to increase this to 20 days. Completion of the course will result in a .25 credit that will be applied toward graduation as an elective course. Students will be required to complete a minimum of 60 hours per course to earn the credit. Director Twiss seconded. Approved unanimously.
