# SCHOOL BOARD MEETING INDEPENDENT SCHOOL DISTRICT #2859 PLACE: Lincoln Meeting Room (Room 124)

DATE: February 9, 2015 TIME: 7:00 p.m.

Board Chair Christianson called the meeting to order at 7:01 p.m. The following members were present: Lindeman, Alsleben, VonBerge, Kuester, Christianson, and Twiss. In addition, Superintendent Chris Sonju; Business Manager Michelle Sander; Principals Bill Butler and Paul Sparby; Student Activities Representative Kole Polzin and Student Government Representative Katie Twiss; Jerry Belcher; Technology Staff Mike Morris; and Superintendent's Secretary Dawn Peterson were in attendance.

The Pledge of Allegiance was recited.

The following announcement was made:

<u>Next School Board Meeting:</u> The next regular School Board meeting will be on Monday, March 9th at 7:00 p.m. in the Lincoln Meeting Room (Room 124).

Superintendent Sonju acknowledged Board members with a certificate and thanked them for their service on the occasion of School Board Recognition Week – February 16-20, 2015.

No public input relating to the agenda was given.

Business Manager Sander reported to the Board.

Principals Butler and Sparby reported to the Board.

Student Activities Representative Polzin and Student Government Representative Twiss reported to the Board.

Superintendent Sonju reported School Board Recognition Week will be the theme next week; he recognized Shopko Foundation for a recent donation of \$1,750, which will be used for an ECFE snack program and some scholarship stuff; reported he and Business Manager Sander are working to put together a schedule for the election, which will kick off at the Glencoe Expo on February 22<sup>nd</sup>; explained the school district is moving forward with a "GSL Digital Day" or "Different Day" and looking ahead to a staff training day on March 2<sup>nd</sup> using Google Classroom; said not everything has to be digital, but in the end this will be a good pilot; told the Board information about "Digital Day/Different Day" will be presented during the March 9<sup>th</sup> Board meeting, and then if we have a school day cancelled, we would be ready; and told the Board we will learn a lot from this and are ready to move forward with it.

Director Lindeman moved to set the years of bond repayment for the building project at 30 years with the final repayment date of February 1, 2045 and an average interest rate of 4.25% for a building project cost of \$23,610,000 with a total project cost of \$24,190,000. Director Twiss seconded. Approved unanimously.

Director Twiss moved to approve the ballot language for the May 12, 2015 special bond election without changes. The question will be:

Shall the school board of Independent School District No. 2859 (Glencoe-Silver Lake Public Schools) be authorized to issue its general obligation school building bonds in an amount not to exceed \$24,190,000 to provide funds for the acquisition and betterment of school sites and facilities in order to relocate grades K-2 to the existing 7-12 campus in Glencoe, to improve safety, to repurpose program space within the current Lincoln Junior High School and GSL High School facilities, and to complete window upgrades at the Lakeside Elementary School facility in Silver Lake?

Director Lindeman moved to approve the Review and Comment for the building project and to submit it to the Commissioner of Education. Director Twiss seconded. Approved unanimously.
