The Board welcomed the public to the meeting.

Superintendent's Report

Dr. Brink reported current enrollment stands at 783 students.

Dr. Brink reported Graduation will be held on May 17, 2024, beginning at 7 pm in the gymnasium.

Dr. Brink presented a draft of the 2024-2025 district calendar. She met with the Superintendents at Smithton, St. Libory, and Freeburg High School to coordinate the calendars. The final copy will be presented to the board next month. A few tentative highlights are:

- August 14 First Day of School
- December 23 January 3 Holiday Break
- May 20 Last Day of School

There was no update from the Illinois Association of School Boards.

- Dr. Brink presented the Principal's Report for the Primary Center. On Thursday, January 11, the Primary Center held a mini-boot camp for PreK-2nd graders to remind students of our three Rs: Respect, Responsibility, and Readiness. This boot camp focused primarily on conduct in the cafeteria, on the playground, and in the restrooms.
- SIP Day on January 12 consisted of grade level data review, disaggregation of IAR scores, etc. January 17th American Heart Association Assemblies kicked off our annual fundraiser. Last year we were one of the top schools in collecting over \$18,000!! This year we are hoping to beat that amount.
- The seven entries for this year's Picture the Music Competition put on by the St. Louis Symphony Orchestra have been selected. The following seven students will have their artwork entered in the competition: K- Madison Heintzelman and Hadley Kreher, 1st grade- Adeline Ainsworth, 2nd grade- Bennett Hannah, 3rd grade- Lyla Frank, 4th grade Savannah Murphy and Anna Wittenauer. Dr. Brink presented the Principal's Report for the Elementary School.

- On Friday, January 5th, the 8th grade students toured the high school in two separate groups.
- The boys' basketball team had a successful season as they finished with an overall record of 17-6. They went undefeated in the regular conference season with a perfect 8-0 record.
- The Chess team began its season on January 8th under the direction of Mr. Tim Havel. This year's club, made up of twenty-one 6th, 7th, and 8th grade students. The team will play four matches a week for four weeks. The Hornets are having a successful year with a record of 4 wins, 1 loss, and 1 tie which currently puts them in first place.
- The Scholar bowl team is currently 3-1. The team split with Red Bud and beat Marissa twice. Their next matches are tomorrow against New Athens and Thursday against Smithton.
- January 12th, the high school FFA students came to Freeburg Elementary to celebrate National Dairy day with the 4th grade classes. Each class got to enjoy homemade ice cream and got to experience milking a cow on the simulator machine.
- The Varsity volleyball team won the Smithton Tournament. They defeated Immaculate Conception School in Columbia in the championship game.
