The Board welcomed the public to the meeting. Eric Vasquez inquired to the Board about the lunch detention procedures. Dr. Brink responded by offering to call Mr. Vasquez tomorrow. He responded by stating email would be preferable.

Superintendent's Report

Dr. Brink stated the Veteran's Day breakfast went very well. There were over 200 attendees and many veterans and first responders expressed their gratitude for the event.

Dr. Brink shared an email from teacher Mrs. Payne mentioning our students were complimented on their behavior during the band field trip on November 15.

Judge Hinz Rudolf will be here next week to speak to our fifth through eighth graders about the dangers of online bullying.

Dr. Brink informed the public the district will be dismissed at 2 pm on December 18 & 19 to align with Freeburg High School. There will be an 11:30 am dismissal on December 20.

The Triple I Conference was held the weekend of November 17 – 19. Board members Scheiebel and Stein attended, along with Dr. Brink and Mr. Janssen. Mr. Stein mentioned he enjoyed the many conferences he attended, including one on strategic planning. He stated the district is on a solid path on our strategic plan. Mr. Scheibel attended the delegate assembly and voted on two noteworthy resolutions. The first was a resolution advocating for the funding of SROs in school and the other is increased investment in the Transportation categorical grant.

Mrs. Fark presented the Principal's Report for the Primary Center. Parent-teacher conferences were held on October 24 & 26 and were well attended. Kindergarten had a sock hop for the 50th day of school. Halloween parties were held on October 31. Santa's Kottage will be held this Friday. The holiday concert will be held at Freeburg High School on December 12, beginning at 7 pm.

Mrs. Zurliene presented the Principal's Report for the Elementary School. In honor of Red Ribbon Week, the K-9 unit came on October 25 for an assembly.
