Kim Hillberg, our auditor from CliftonLarsonAllen, LLP, provided an overview of the audit summary and financial statements for the school district for the 2012-2013 school year at the October 14<sup>th</sup> Board meeting. Director Alsleben moved to accept the audit summary and financial statements for the 2012-2013 school year as prepared by CliftonLarsonAllen, LLP. Director Kuester seconded. Approved unanimously.

Director Twiss moved to approve ECFE Director Jan Mackenthun's contract from July 1, 2013 through June 30, 2015. Director Lindeman seconded. Approved unanimously.

Director Twiss moved to adopt the resolution amending the school district's 125 Flexible Benefits Plan in order to reflect the decision of the Supreme Court of the United State's definition of "spouse." The revised definition of "spouse" is intended to be applied consistent with applicable regulatory guidance, including IRS Revenue Ruling 2013-17. Board Chair Christianson seconded. Approved unanimously.

Director Alsleben moved to approve the 2013-2015 Youth Development Plan in order to receive youth services revenue in the amount of \$1 per capita for the 2013-2014 and 2014-2015 school years in accordance with Minnesota State Statute 123D.20. The Community Education Advisory Council has approved the plan. Director VonBerge seconded. Approved unanimously.
