Board Chair Christianson called the meeting to order at 7:00 p.m. The following members were present: Kuester, Lindeman, Alsleben, VonBerge, Christianson, and Twiss. Superintendent Sonju acknowledged the School Board members during School Board Recognition Week – February 15-19, 2016 – presented them with a certificate of appreciation, and thanked them for their service to our school district.

Business Manager Sander reported to the Board.

Principals Butler, Freitag, and Svoboda reported to the Board.
