The entire kitchen staff here at Glencoe-Silver Lake Schools is excited to welcome students back to school where they will experience new flavors, and events sure to inspire a happy and healthy 2023-24 school year! We do more than feed hungry students at GSL Public Schools. We improve the well-being of our students by preparing fresh, delicious and nutritious meals they love. We engage students and all of their senses through the creation of new and fresh dining experiences that improve their school day. Our wide variety of menu items, programs and initiatives nourish student's bodies, minds and spirits.

Breakfast Items - The fruit smoothie bar served Tuesday thru Thursday, as well as the Made-To-Order Omelet station on Wednesday mornings will continue weekly. New breakfast items will continue to roll out as the year goes forward.

Lunch Items – The “Sono” line was a huge success, and we will continue to add condiments to keep it fresh and exciting. It is our version of “Chipotle” and we will offer it daily at the HS. We will continue to run a Student Choice sampling station throughout the year so we can see how new items jive with students taste buds and incorporate them into the menu.

Snacks

Hydroponic Gardening

We also plan on rolling out a new hydroponic program where we will be growing our own lettuce and herbs. The growing machine is called a “Flex Farm”, takes up only four-square feet, and can grow 3.5 lbs of lettuce in 6 weeks to be used in our lunch program. Dietary Needs

Chartwells believes managing food allergies is not just about helping children avoid the foods to which they are allergic, it is also about providing safe and nutritious meals in an environment in which they feel comfortable and accepted. All special dietary requests must be written by a physician and submitted to the school nurse and food service office. A copy of the special dietary request form can be found on the school website or in the school nurse's office.

The Nutrislice App powers our school menu, nutrition and allergen information right to your mobile phone. In addition to nutrition information, Nutrislice tells the café menu story with real photos taken by Chartwells chefs in schools, full menu descriptions as well as café event information, nutrition education and food stories helping students connect the food they eat in the café to its origins and health benefits.

Meal Prices for 2023-2024 School Year

Our School offers healthy meals each day. Starting school year 2023-2024, we are joining Minnesota's Free School Meals Program. All students can get one breakfast and one lunch free of charge each day at school. After School Snack will be cost \$1.85.

Although no application is required to receive this free meal benefit, filling out the Application for Educational Benefits is still important! Your child(ren) may qualify for other benefits like reduced fees at school or reduced price for after school snack. Your application may also help the school qualify for education funds, discounts, and other meal programs. A new application must be submitted each year. Applications can be found on the school website, at the District Office, or during check in and open house days. Completed applications can be emailed to Trisha Zajicek TZajicek@gsl.k12.mn.us, dropped off at the District Office, or send to Glencoe-Silver Lake, Attn: Trisha Zajicek, 1621 16th St E, Glencoe, MN 55336.



Students are also able to get a 2nd meal for a cost of \$2.65 for K-6 and \$2.85 for 7-12. An extra milk or to purchase just a milk is \$.50 cents. 7-12 graders are also able to purchase A la Carte items. These purchases are charged to their lunch accounts or can be purchased with cash. If you wish for your child to not have seconds or purchase A la Carte items, contact Trisha Zajicek.

Student-School Health Information

As you prepare for the return to school, here is what you need to know about keeping your child safe and healthy at school:

- Every year GSL's Health Department asks you to fill out a health survey for each of your students. It is very important that you fill this out to the fullest extent each academic year. We do not keep this form from year to year. Old information does not carry over. Student health surveys may be turned in during the Open house.
- **Prescription medications** cannot be given in the school setting until we have received an authorization form with signatures from both the physician and parent.
- **Inhaler/Epi pens:** Please remember that students CANNOT self-carry/self-administer unless it is advised by the physician (this information is included on the form mentioned above).

- **Do you have questions regarding medication administration in schools?** Please review our policy 516, Student Medication Policy (available on GSL's website at www.gsl.k12.mn.us). If you have further questions please contact me or your student's building health office.
- **Immunizations:** Please ensure your student is up to date on their immunizations, and that you provided the school with an updated shot record. We check immunization status annually and are required to report our findings to the State of Minnesota.
- **Forms are Online!** You can access health forms mentioned, on the school website. For all students, regardless of age, select “schools” then “high school.” Under the links on the right-hand side, select “health department,” and on the right hand side you can find forms under “Contents.” If you have additional health questions/concerns, please contact me or your student's building health office.

What is “P.A.C.” (Panther Adventure Club) all about?...

The P.A.C. program is offered by the GSL Community Education department to provide child care for students attending Kindergarten (fall 2023) through 6th grade, who would normally be at home alone or without parental supervision.

Our program is designed to meet the needs ranging from: snack, homework time, gym time, group games, art projects, outdoor play, quiet, down time with board games and puzzles.

There are so many things to do at P.A.C. with friends the same age~everything your child needs to have fun in a safe and well-supervised environment, with caring and professional staff. Whether you need care every day, or you are looking for some options for your daughter or son, the Panther Adventure Club program is here for you!

Please be advised:

- When school starts late due to weather, the Panther Adventure Club (PAC) morning program will be canceled. Please watch/listen for the report on the television or radio.
- When school is closed due to the weather the PAC program is closed.
- Alternate plans are necessary for your child on days when school starts late or gets out early due to weather or other emergencies. Please talk to a neighbor or friend and make arrangements for your child to go to their house in the event of an emergency school closings.
- When we go outside, in the gym, or leave the site a sign will be posted. We will try and adhere to a schedule of days and times when we leave so you will know where and when to find us.

6:30 AM - 8:00 AM Monday through Friday (before school)
3:00 PM - 5:30 PM Monday through Friday (after school)
Participants will need to provide a schedule

Transportation:

- AM P.A.C. program, transportation to your child’s school from the Lincoln P.A.C. site is provided.
- PM P.A.C. program, Transportation from your child’s school to the Lincoln P.A.C. site is provided.
- Transportation times will coincide with the regularly scheduled bus routes for your child’s school. Before school, drop your child off at the Lincoln P.A.C. site. After school your child will ride the bus back to Lincoln PAC site. At the end of the day, pick your child up at the Lincoln PAC site.

Meals:

Breakfast will be offered in the AM and is optional.
Snack will be offered in the afternoon and is optional.

Fees:

- Weekly fee for school year participation in both AM and PM is \$60.00 per child.
- Daily AM fee is \$5.00 and daily PM fee is \$8.00 per child.
- Non-School, Full Release days are \$27.00 per child.
- Registration Fee of \$10.00 per child needs to be paid prior to child attending the program.

Fees are based on the schedule you provide. Students who miss due to illness or other reasons are still respon sible for their full weekly tuition.

Fees include:

- Caring/Professional staff
- Special events/programs
- Breakfast/Afternoon snack
- Choice Activities/Activity Materials
- Quality care

Dates:

- The 2023-2024 SCHOOL YEAR program begins September 5 and ends May 26.
- The 2023 SUMMER PROGRAM will begin June 2. (Dates are subject to change with the GSL school calendar)

Non-school days when P.A.C. is open if care is needed:

December 26, 27, 28, & 29	January 2 & 15
February 19	March 25, 26, 27, & 28

Days when P.A.C. is closed:

September 4	November 23 & 24
December 25	January 1

Registrations:

- Registrations are accepted on a first-come, first-served basis with full-time registrations receiving priority over part time registrations.
- Drop-ins will be accepted, but participants must be registered with the program in order to use drop-in services.
- Participants in drop-in services require a 48 hour notification.
- Registration/Activity fees are nonrefundable. School year program participants waive Summer ‘24 registration fee.

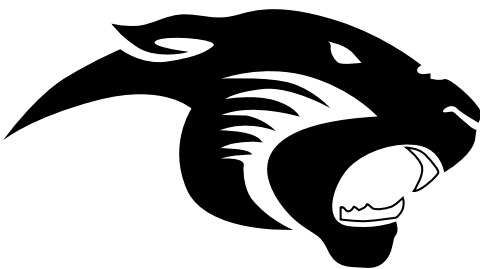

Time to Talk Roofs



Welcome to the start of another school year. The years continue to fly by as I am now starting my 17th year at GSL Schools. We have accomplished a lot of projects over the past years and have made a lot of substantial improvements to our facilities. You should be proud as a community of the wonderful facilities that we have. Maintaining 386,000 square feet of buildings takes a lot of planning, time and effort and of course money. We have utilized our Long Term Facilities Maintenance Revenue to fund most of the projects that we have completed. Some of the projects that we have completed this summer includes; crack repair and seal coating at our high school and Lincoln parking lots. Completed bathroom remodels at Lincoln Elementary and continued with our classroom ceiling projects at Lakeside completing another 4 classrooms. The high school band room received new instrument storage units along with paint, carpet and new ceiling tiles. Another 100 feet of hot water lines were also replaced at the high school. It is always fun to see the completion of projections as we continue to improve and maintain our buildings.

Over the years the one thing that we have not talked about too much is the roofs on our buildings. We have had a few issues here and there, completed some regular maintenance, and taken care of leaks as they arise, but have not put together a solid plan for replacement, even though it continues to be on our project list.

This spring we worked with a company to complete a Roof Asset Management Plan to help us better understand the ages and conditions of our roofs. Not to anyone’s surprise, we are reaching the life expectancy on some of our roofs. 78% of our roofs are now 19+ years old with two areas that are 27 years old. We need to get started on this project plan within the next two years. So we have a little time, but projects like this take planning time. You have to lay out your long term replacement plan, design your roof system, bid the projects and of course figure out how to pay for it!

Our goal is to develop a 10-year district wide plan for replacing and restoring the roofs as they reach the end of their service life. The preliminary budget projection is \$5.35 - \$6.49 million based on current assumptions. We still need to complete additional site diagnostics and core samples to provide us additional information that could affect the budget.

Our next step is to meet with the district’s financial advisors to discuss funding options and how this would affect our taxpayers. The one option would be a Capital Project Levy. This would require voter approval and is limited to 10 years. With this type of funding, no debt is issued because the funds come to the district through the levy process and a separate capital project account is established for these funds that can only be used for this project.

The board is planning a work session for August to learn more about roofs and roof financing. This is new territory for us so we have more to learn and questions to ask. The board feels strongly about having a solid plan in place for this project so the building roofs are in the best shape possible for the next 40+ years. And, just when I thought I might get bored.....I guess one is never too old to learn something new!

GSL Panther Field House will be offering passes for students that plan to be in an activity for a cost of \$75. This pass will be good from August 14th, 2023 to May 31st, ,2024. Students must be in an activity, or plan to be in an activity to get this rate (Grades 7-12). These passes need to be purchased in the Activities Office.

In order to protect our students, GSL provides ImPACT Testing. ImPACT (Immediate Post-Concussion Assessment and Cognitive Testing) is the first most widely used and most scientifically validated computerized concussion evaluation system. Given the inherent difficulties in concussion management, it is important to manage concussions on an individualized basis and to implement baseline testing and/or post-injury neurocognitive testing. This type of concussion assessment can help to objectively evaluate the concussed athlete's post-injury condition and track recovery for safe return to play, thus preventing the cumulative effects of a concussion.

School bus expectations and policy

ALL STUDENTS must ride their designated buses unless a written note from the parent(s) or guardian(s) is brought to school. If a student is going to ride a different route, a signed note must be presented to the classroom teacher or office. The teacher will sign the note and it is then handed to the driver of the bus. Without parental and school permission, no student is allowed on an alternate bus route. Buses will stop only at regularly scheduled stops.

Glencoe-Silver Lake school buses transport students in grades K-6 who live more than one mile from the schools they attend or students in grades 7-12 who live over two miles walking distance from the school they attend.

The bus driver will make every effort to abide by the schedule. Extremes in weather and poor roads do occasionally cause minor deviation from the schedule. The care and discipline of children on the bus lies solely with the bus driver.

Your assistance is requested to encourage good safety and citizenship. Children are asked to obey the following rules when riding the bus. The bus driver is in charge of enforcing the following rules:

- Walk onto the bus
- Listen to bus driver
- Use a quiet voice and respectful language
- Sit and face forward
- Keep hands, feet, and objects to yourself
- Walk off the bus

All misbehavior cases should be reported to Tina Teubert at the transportation office (320-864-3032).

Parents or guardians will be notified of any suspension of bus privileges. Consequences for elementary students may include, but are not limited to:

- 1st offense – warning
- 2nd offense – three-school-day suspension from the bus.
- 3rd offense – five-school-day suspension from the bus.
- 4th offense – 10-school-day suspension from the bus/meeting with parent.
- Further offenses – individually considered.

Note: When any student goes 60 transportation days without a report, the student’s consequences may start over at the first offense.

The safety of our students is of primary concern to the bus drivers. Here are “bus stop expectations” to discuss with your child:

- Listen to the supervisor
- Play safely and kind
- Be friendly
- Line up when buses arrive



School bus safety

Students will be given school bus safety information the first weeks of school. Training will take place in the classroom and on a school bus. Parents, students and bus drivers play an important role in school bus safety. Bus drivers attend training meetings on issues including first aid, safe driving, and transporting students safely to and from school. Students need to practice, follow the bus rules and respect the rights and privileges of others. Parents should:

- Make sure students understand the transferring to other buses in the morning and afternoon to get to school and home.
- Make sure elementary students know their name, address, telephone number and bus number.
- Be at the bus stop the first couple of times or until the student is comfortable about the bus stop.
- Send a note along with the student if there are any changes in pick-up or drop-off.
- Remind students to always look both ways before crossing any street or roadway.

You, as a parent/guardian, are responsible for your child's comprehension of the school bus safety information. Transportation to and from school can be safe and efficient when riders cooperate with the bus driver, teachers and other passengers.

Get together and form a walking bus

Studies show that fewer children are walking and biking to school, and more children are at risk of becoming overweight. Changing behaviors of children and parents requires creative solutions that are safe and fun. Implementing a walking bus can be both. One of the primary reasons why parents are reluctant to allow their children to walk to school is because of safety issues. Many children are now driven to and from school every day. A walking bus gives more children the opportunity to walk to school safely every day. Items to consider include:

1. The school district is not responsible for students participating in a walking bus. Parents are responsible for their own children.
2. To begin, invite children from families who live nearby to walk.
3. Pick a route and take a test walk.
4. Take a look at the sidewalks or paths along the route.
5. Consider the traffic. How busy are the streets?
6. Look at the crosswalks along the route. Is it easy to cross the street?
7. Everyone meets at a pre-arranged time and walks to school together. More students will join the walking bus just because they see it.

There are benefits to a walking bus:

1. It’s sociable, healthy and enjoyable.
2. It reduces parking problems near the entrance of school buildings.
3. Children learn about safety and become more aware of their environment.

**Data privacy policy
(Release of student information)**

The school will observe the following policy to conform to the requirements of the Family Rights and Privacy Act of 1974: Student pictures and identifying names will be printed in the school yearbook and all district publications and given to the local news media on occasions that warrant it. However, any student, or the student's parent, if the student is under the age of 18, may request that his/her picture not be published or information released in the news media or school publications. Requests are to be made in writing to the building principal.

Participation in any group picture implies consent for release of picture with name.

This policy does not apply to pictures taken by the news media or information gathered and printed by the media. Due to yearbook publication deadlines, students must submit requests prior to December 15. The school district recognizes its responsibility in regard to the collection, maintenance and dissemination of pupil records and the protection of the privacy rights of students as provided in federal law and state statutes. Directory information means information contained in an education record of a student which would not generally be considered harmful or an invasion of privacy if disclosed. It includes, but is not limited to: the student's name, address, telephone listing, date and place of birth, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, degrees and awards received and the most recent previous educational agency or institution attended. This information is public data on individuals. Directory information does not include personally identifiable data which references religion, race, color, social position or nationality. The parent or adult student has the right to refuse to permit the designation of some or all of the categories as directory information with respect to that particular student. If the parent or student notifies the school district that they don't want this information designated as directory information, the classification remains private.

Indoor air quality notice

Glencoe-Silver Lake school district is proud to be taking a leadership role in providing a safe, comfortable and productive environment for our students and staff so that we achieve our core mission – educating students. Our school will follow the EPA guidance to improve our indoor air quality by preventing as many IAQ problems as possible, and by quickly responding to any IAQ problems that may arise. Good air quality requires an ongoing commitment by everyone in our school because each of us daily makes decisions and performs activities that affect the quality of the air we breathe. School staff, students and parents can obtain checklists or self-help information so they can properly evaluate their child's home or other out-of-school situation by contacting the school. Staff and parents can also obtain information about school facility construction, maintenance and

housekeeping practices, chemicals used, mold and HVAC related information, chemical producing academic subjects, and pesticide and herbicide applications to determine the extent to which school activities contribute to a child's symptoms by contacting the school. The Glencoe-Silver Lake School District Indoor Air Quality contact person is Cullen Ober, Dashir Management Company, 320-510-0825. **2023-2024 school year
asbestos notification**

Federal legislation (Asbestos Hazard Emergency Response Act – AHERA) requires each primary and secondary school in the nation to complete a stringent inspection for asbestos and to develop a plan of management for all asbestos-containing building materials. Glencoe-Silver Lake Public Schools have a goal to be in full compliance with this law. As a matter of policy, the district shall continue to maintain a safe and healthful environment for our community's youth and employees.

Cullen Ober, Dashir Management Company, is the person designated as Asbestos Program Manager for our schools. He can be contacted at 320-510-0825. An operation and maintenance program is in place through which we respond to our ACBM on a continuing basis. In keeping with this legislation, all buildings owned or leased by Glencoe-Silver Lake Public Schools were inspected by EPA-accredited inspectors and samples were analyzed by an independent laboratory. Based on the inspection, the school prepared and the state approved a comprehensive management plan for handling the asbestos located within its buildings safely and responsibly. During the last school year, Glencoe-Silver Lake Public Schools conducted the following with respects to its asbestos containing building materials: Boiler rooms and tunnels at Lincoln and High School – pipes and glove bagging Federal law requires a periodic walk-through (called “surveillance”) every six months of each area containing asbestos. In addition, the law requires all buildings to be re-inspected three years after a management plan is in effect. Musser Environmental Consulting, Inc. will accomplish this under contract. Areas where management issues are noted during inspections and surveillances have been, and will continue to be, dealt with promptly. Short-term workers (outside contractors, i.e., telephone repair workers, electricians and exterminators) must be provided information regarding the location of asbestos in which they may come into contact. All short-term workers shall contact Cullen Ober, Dashir Management Company, 320-510-0825, before beginning work in order to be given this information. Glencoe-Silver Lake Public Schools has a list of the location(s) and type(s) of asbestos containing materials found in the school buildings and a description and time-table for their proper management. A copy of the Asbestos Management Plan is available for review in the District Office. Copies are available at 25 cents per page. Questions related to the plan should be directed to Steve Musser, Musser Environmental Consulting, Inc., 3085 Prairie Rose Drive, Mankato, MN 56001, by calling 651-388-7139, or by contacting the Glencoe-Silver Lake School District at 320-864-2491.

Employment and services criminal history background check notice to parents

The school district has adopted a policy, the purpose of which is to promote the physical, social, and psychological

well-being of its students. Pursuant to this policy, the school district shall seek criminal history background checks for all applicants who receive an offer of employment with the school district. The school district also shall seek criminal history background checks for all individuals, except enrolled student volunteers, who are offered the opportunity to provide athletic coaching services or other extracurricular academic coaching services to the school district, regardless of whether compensation is paid. These positions include, but are not limited to, all athletic coaches, extracurricular academic coaches, assistants, and advisors. The school district may elect to seek criminal history background checks for other volunteers, independent contractors, and student employees.

Minnesota school districts responsible for identification of students with disabilities

In response to the individuals with Disabilities Education Improvement Act (IDEIA), Minnesota Districts must demonstrate that “all children with disabilities, including children with disabilities attending private schools, regardless of the severity of their disabilities and who are in need of special education and related services, are identified, located and evaluated.” This responsibility extends to children with disabilities who receive their formal education in a private school. Home schooled children are considered private school children in Minnesota. Upon request, the Glencoe-Silver Lake Public School District will provide information to concerned parents on specific disabilities including information about the educational or behavioral manifestations of each disability. Parents who believe their child may indeed have a disability may request procedural information on how to arrange for an evaluation through the Glencoe-Silver Lake Public School special education staff. Parents of students who are evaluated and are found to be eligible for special education services will become part of a team that will develop, implement, and monitor the effectiveness of an Individualized Education Plan to meet the identified needs of their children. If you have any questions or would like to receive information about specific disabilities or evaluation, please contact the principal of the school building your child would attend in the Glencoe-Silver Lake Public School District if he/she were not being home schooled. The Glencoe-Silver Lake Public School is committed to promoting academic success for its students.

Bullying is expressly prohibited on school district property or at school-related functions

A safe and civil environment is needed for students to learn and attain high academic standards and to promote healthy human relationships. Bullying, like other violent or disruptive behavior, is conduct that interferes with students’ ability to learn and teachers’ ability to educate students in a safe environment. The school district cannot monitor the activities of students at all times and eliminate all incidents of bullying between students, particularly when students are not under the direct supervision of school personnel. However, to the extent such conduct affects the educational environment of the school district and the rights and welfare of its students and is within the control of the school district in its normal operations, it is the school district’s intent to prevent bullying and to take action to investigate, respond, remediate, and discipline those acts of bullying which have not been successfully prevented. The purpose of Policy 514, Bullying Prohibition Policy, is to assist the school district in its goal of preventing

and responding to acts of bullying, intimidation, violence, and other similar disruptive behavior. An act of bullying, by either an individual student or a group of students, is expressly prohibited on school district property or at school-related functions. This policy applies not only to students who directly engage in an act of bullying but also to students who, by their indirect behavior, condone or support another student’s act of bullying. This policy also applies to any student whose conduct at any time or in any place constitutes bullying that interferes with or obstructs the mission or operations of the school district or the safety or welfare of the student, other students, or employees. The misuse of technology including, but not limited to, teasing, intimidating, defaming, threatening, or terrorizing another student, teacher, administrator, volunteer, contractor, or other employee of the school district by sending or posting e-mail messages, instant messages, text messages, digital pictures or images, or website postings, including blogs, also may constitute an act of bullying regardless of whether such acts are committed on or off school district property and/or with or without the use of school district resources. (Refer to Policy 524, Internet Acceptable Use and Safety Policy, for more information). Any person who believes he or she has been the victim of bullying should report the alleged act(s) immediately to an appropriate school district official. The harassment report form is available from the principal of each building or in school offices, but oral reports will be considered complaints as well. Notice concerning use of pest control materials

The GSL school district utilizes a licensed, professional pest control service firm for the prevention and control of rodents, insects, and other pests in and around the district's buildings. Their program consists of: 1. Inspection and monitoring to determine whether or not pests are present, and whether any treatment is needed; 2. Recommendation for maintenance and sanitation to help eliminate pests without the need for pest control materials; 3. Utilization of non-chemical measures such as traps, caulking and screening; and 4. Utilization of EPA registered pest control materials when needed. Pests can sting, bite, cause contamination, damage property, and spread disease; therefore, we must prevent and control them. The long-term health effects on children from the application of such pest control materials, or the class of materials to which they belong, may not be fully understood. All pest control materials are chosen and applied according to label directions per Federal law. Information about the scheduling of interior pest control inspections and possible treatments is available by contacting Cullen Ober, Dashir Management Company, at 320-510-0825. Similar information about the scheduling for application of herbicides and other materials to school grounds is also available by contacting Mr. Ober. Parents of students may request to receive prior notification of any application of a pest control material, should such an application be deemed necessary on a day different from the days specified in the schedule. Community Education, Early Childhood Family Education, and Preschool classes, as well as elementary and secondary activities, will not be held when school is closed due to inclement weather. When school is two hours late, there will be no ECFE or preschool classes. Please don't call the schools to find out early closing information. This ties up the phone lines so that emergency calls can't get through.

Radio and TV stations will provide a specific closing time (for example: 12:00 noon), rather than listing it building by building. Buses cannot be at all four buildings at the same time, so dismissal times are staggered. Listed below are the scheduled times for a 12:00 noon early dismissal:

Generally, school will be in session if it is felt that the buses can make their routes in relative safety. However, when weather conditions are questionable, the district's road conditions are checked and a determination is made as to whether or not to start late, dismiss school early, or close.

Even if school is in session, parents are asked to assess their particular situation to determine whether or not it is safe for their child(ren) to attend school on a particular day. During inclement weather, parents may take their child(ren) home at any time during the day by reporting to the principal's office in the building the child(ren) attend(s).
