Let's Get the Year Started...

I want to start by saying "Thank You". First, thank you for your support of the GSL school system. Community support is a vital part of the success of a district. By attending events, making donations, supporting our elections, volunteering at school functions, helping in the classroom. It all makes a difference to our students. Second, I just want to say a big thank you for your support, patience, understanding and flexibility over the past year during our construction project. What a year it has been. There has been a number of construction 'detours" along the way, especially to our field house members. Moreover, to our families and students that have had to maneuver through construction to get to the pool, and to summer band lessons. We do have a mess. However, the mess is getting to be less. And, the end is in sight. We do know that not everything will be 100% complete once we start school, but eventually all of the punch list items will be taken care of.

So, you might be wondering what is next. Well, we have a long list yet of projects that need to be completed. Each year, the board has to approve a Ten-Year Long Term Maintenance Facilities Revenue Plan. This is also referred to as LTFMR. I work directly with our Facilities Manager and board members to develop the plan. We identify all areas in our buildings that need to be addressed. From roofs, to plumbing to cement work to parking lots to carpets.

We identify and prioritize all of our projects to see what needs to be taken care of first and always looking at anything that could affect our staff and students safety. The LTFMR is a combination of state aid and local levy and brings in about \$500,000 of revenue to the district that has to be reserved for the purposes identified in statute. Therefore, we cannot use the money for salaries, or computers, or vehicles. It is strictly for deferred maintenance projects.

The next big project that we will be tackling will be the high school north parking lot. This project has been on our list and would have been completed this summer, but with all of the construction, we postponed it until next summer - 2018. It did not make sense to attempt and complete this project while we still had so many construction vehicles, equipment and trailers that would be in the way. This project will take some coordination of parking and accessing the field house and the north side of the high school. Needless to say, you might have one more summer of inconvenience. Even in the summer, we have a very busy parking lot, so we will have to have a plan for alternative parking while the lot is being completed. Another project that will hopefully be completed over the next couple of months will be moving the Helen Baker outdoor library garage.

The plan is to move this building to the high school campus. No, it will not be used as a library but for storage. It seems there is never enough storage for "stuff". So, if you see a large garage coming down

16th street, you might want to get out of the way! We have started our annual audit process. Always a very busy time to get everything gathered for the auditors. We should see final audit numbers by the October board meeting.

As always, call or stop in if you have questions. Watch for upcoming news about a building open house that we will hold for the community. It is very important to us to make sure the community has a chance to see what has been accomplished with the construction. It will not be perfect, but it will be awesome.

What exactly is an "Elementary PTO?"

Parent — Parenting touches all aspects of our children's lives, especially their education during these formative years. It is not uncommon, then, for parents to reach out and be involved in the elementary schools, whether it is volunteering to chaperone a field trip, attending a parent-teacher conference, or sending a supportive e-mail to your child's teacher!

The GSL Elementary PTO gives parents a way to encourage the faculty and students by providing community-building events on a large scale and morale boosters to teachers on a smaller scale.

Teacher – The PTO has both parents and teachers in our core group. The principals of both schools and teacher liaisons from each building provide input on how the PTO can best meet the needs of students, families, and staff. Parents can make such a differ-

GSL Booster Club

Dear Students/Parents:

Welcome to the 2017-2018 school year. We look forward to a great year. Items printed in bold are new items or changes from previous years, so please take a few minutes to review. With the new construction, we will now have one JH/HS office. Please contact 320-864-2400 with any office questions. During the course of the school year, we, as a school, will be engaging in many different activities, programs, and events that will provide your child with the best educational experience possible. We will do everything to make this school year the best yet. Our expectations for our students, staff, and community are high. We expect great things because we have great people in our school system. From students to staff, and parents to community members, we want and will expect the best. The start of a school year is a wonderful opportunity to get a "fresh start" and make the most of each and every day.

Our open house at the Glencoe-Silver Lake Junior-Senior High School will be on Tuesday, September 5th from 7:30am-6:30pm. We will have a large group meeting in the high school auditorium starting at 5:00pm. We will be discussing our new schedules and grading procedures, so I would encourage all parents and students to attend. We will also be discussing our initiative of having "every student complete every assignment!" The rest of the time during open house, parents and students will have an opportunity to visit and tour both buildings. Please print your schedules prior to attending the open house. We encourage all students & parents to make every effort to attend our open house. This organizational time is very important before the actual first day of school.

The first day of school, Wednesday, September 6th, is coming up quick and the administration and staff are looking forward to a great school year. The school day begins at 7:55AM and students will be dismissed at 3:10PM. I have split this letter into two separate sections, one specifically for students and one for parents.

Students

Planners:

Each high school student is responsible for paying for their student planners (\$5.00). GSL Schools will provide every junior high student with a planner, but if they lose their planner, they will have to pay for the replacement. Please bring the money on the first day and your RAP advisors will be collecting your money and handing out the planners. Remember that the planners can be a useful tool in organizing your daily activities and homework and we will continue with the pass system that is located in your planner; no planner – no passes out of class.

Lockers & Locks:

We will be providing padlocks for all lockers and requiring that students keep them locked at all times. Student locker numbers and padlock combinations are listed on their class schedule sheet. A \$10.00 fee will be assessed for any lost padlocks or padlocks that are not turned in at the end of the school year. Personal padlocks are not allowed on school lockers and will be removed if found. You will also be fiscally responsible for any damage to your locker.

Class Schedules:

Although the schedules are complete, there may be some minor changes before the first day. You can access your schedule on the parent portal. Please confirm your schedule before the first day of school in case changes have been made. Please note that your RAP advisor and locker assignment/combination is listed on your schedule.

In order to foster and promote accountability in our student body and maintain fiscal responsibility, we are expecting parents and students to view grades/report cards on our parent portal. Grades are available to be viewed at any time. We will not be sending home paper copies of mid-tri or report cards. Paper copies are available upon request from the Junior/Senior High office.

Transportation:

- AM P.A.C. program, transportation to your child's school from the Lincoln P.A.C. site is provided.
- PM P.A.C. program -Transportation from your child's school to the Lincoln P.A.C. site is provided.
- Transportation times will coincide with the regularly scheduled bus routes for your child's school. Before school, your child is dropped off at the Lincoln P.A.C. site. After school your child will ride the bus back to Lincoln PAC site. At the end of the day, your child is picked up at the Lincoln PAC site.

Meals:

Breakfast will be offered in the AM and is optional. Snack will be offered in the afternoon and is optional.

Fees:

- Weekly fee for school year participation in both AM and PM is \$55.00 per child
- Daily AM fee is \$4.50 and daily PM fee is \$7.00 per child
- Non-School, Full Release days are \$25.00 per child
- Registration Fee of \$10.00 per child needs to be paid prior to child attending the program.

Fees are based on the schedule you provide. students who miss due to illness or other reasons are still responsible for their full, weekly tuition.

Registrations:


- Registrations are accepted on a first-come, first-served basis with full-time registrations receiving priority over part time registrations.

School bus safety

Students will be given school bus safety information the first weeks of school. Training will take place in the classroom and on a school bus. Parents, students and bus drivers play an important role in school bus safety. Bus drivers attend training meetings on issues including first aid, safe driving, and transporting students safely to and from school. Students need to practice, follow the bus rules and respect the rights and privileges of others. Parents should:

- Make sure students understand the transferring to other buses in the morning and afternoon to get to school and home.
- Make sure elementary students know their name, address, telephone number and bus number.
- Be at the bus stop the first couple of times or until the student is comfortable about the bus stop.
- Send a note along with the student if there are any changes in pick-up or drop-off.
- Remind students to always look both ways before crossing any street or roadway.

You, as a parent/guardian, are responsible for your child's comprehension of the school bus safety information. Transportation to and from school can be safe and efficient when riders cooperate with the bus driver, teachers and other passengers.

School bus expectations and policy

LL STUDENTS must ride their designated buses unless a written note from the parent(s) or guardian(s) is brought to school. If a student is going to ride a different route, a signed note must be presented to the classroom teacher or office. The teacher will sign the note and it is then handed to the driver of the bus. Without parental and school permission, no student is allowed on an alternate bus route. Buses will stop only at regularly scheduled stops.

Glencoe-Silver Lake school buses transport students in grades K-6 who live more than one mile from the schools they attend or students in grades 7-12 who live over two miles walking distance from the school they attend.

The bus driver will make every effort to abide by the schedule. Extremes in weather and poor roads do occasionally cause minor deviation from the schedule. The care and discipline of children on the bus lies solely with the bus driver.

Your assistance is requested to encourage good safety and citizenship. Children are asked to obey the following rules when riding the bus. The bus driver is in charge of enforcing the following rules:

- Walk on to the bus
- Listen to bus driver
- Use a quiet voice and respectful language
- Sit and face forward
- Keep hands, feet, and objects to yourself
- Walk off the bus

All misbehavior cases should be reported to Terry Becker at the transportation office (320-864-3032).

Parents or guardians will be notified of any suspension of bus privileges. Consequences for elementary students may include, but are not limited to:

- 1st offense warning
- 2nd offense three-school-day suspension from the bus.
- 3rd offense five-school-day suspension from the bus.
- 4th offense 10-school-day suspension from the bus/meeting with parent.
- Further offenses individually considered.

Note: When any student goes 60 transportation days without a report, the student's consequences may start over at the first offense.

The safety of our students is of primary concern to

the bus drivers. Here are "bus stop expectations" to discuss with your child:

- Listen to the supervisor
- Play safely
- Be friendly
- Line up when buses arrive





Get together and form a walking bus

Studies show that fewer children are walking and biking to school, and more children are at risk of becoming overweight. Changing behaviors of children and parents requires creative solutions that are safe and fun. Implementing a walking bus can be both. One of the primary reasons why parents are reluctant to allow their children to walk to school is because of safety issues. Many children are now driven to and from school every day. A walking bus gives more children the opportunity to walk to school safely every day. Items to consider include:

- 1. The school district is not responsible for students participating in a walking bus. Parents are responsible for their own children.
- 2. To begin, invite children from families who live nearby to walk.
- 3. Pick a route and take a test walk.
- 4. Take a look at the sidewalks or paths along the route.
- 5. Consider the traffic. How busy are the streets?
- 6. Look at the crosswalks along the route. Is it easy to cross the street?
- 7. Everyone meets at a pre-arranged time and walks to school together. More students will join the walking bus just because they see it.

There are benefits to a walking bus:

- 1. It's sociable, healthy and enjoyable.
- It reduces parking problems near the entrance of school buildings.
- Children learn about safety and become more aware of their environment.

GSL Supermileage Team Update

The GSL Supermileage Team competed in the 29th annual MTEEA Supermileage Challenge at Brainerd International Raceway May 15-16. Students competed in 3 classes with 4 vehicles. Students have been working all year on building two new vehicles, adding fuel injection to a previously entered vehicle and modifying the Ethanol vehicle.

In an effort to increase support and promote Technology Education, public awareness in the area of fuel economy and student involvement, a fuel economy competition is held every spring. Competing students and clubs are challenged to build a one-person, fuel-efficient vehicle powered by a single cylinder four stroke cycle engine. The 29th annual competition featured vehicles to compete in Stock, Modified, E-85, Experimental and Plug in Electric classes.

Students from GSL built a new car, Purple Rain, to compete in the Electric class. Piloted by veteran Eric Villnow, Jacob Jochum, and Adam Thalmann, the vehicle successfully completed 14 runs without a single breakdown. The highest mileage run was equivalent to 2153 mpg. The second new vehicle, Little Red Corvette, was built for the modified class. Unfortunately, the vehicle had mechanical issues both days that students were unable to sort out and never successfully completed a run. The Blue vehicle returned again but this year running a new fuel injection system. The vehicle also suffered from mechanical problems, but finished two runs achieving a high mileage of 135 mpg. The fourth entry, the Pink Cadillac, was entered into the E-85 classs where it completed 6 runs with a new school record of 228 mpg, driven by sophomore Isaac Swift.

This years team included: Carl Hormann, Jacob Jochum, Michaela Neyer, Blake Ortloff, Kole Polzin, Isaac Swift, Roxanna Sanchez, Adam Thalmann, and Eric Villnow.

Student-School Health Information

S you prepare for the return to school, here is what you need to know about keeping your child safe and healthy at school:

- Every year GSL's Health Department asks you to fill out a **health survey** for each of your students. It is <u>very</u> important that you fill this out to the fullest extent each academic year. We do not keep this form from year to year. Old information <u>does not</u> carry over. Student health surveys may be turned in during the Open house on September 5th.
- **Prescription medications** cannot be given in the school setting until we have received an authorization form with signatures from both the physician and parent.
- Inhaler/Epi pens: Please remember that students CANNOT self-carry/self-administer <u>unless</u> it is advised by the physician (this information is included on the form mentioned above).
- Do you have questions regarding medication administration in schools? Please review our policy 516, Student Medication Policy (available on GSL's website at www.gsl.k12.mn.us). If you have further questions please contact me or your student's building health office.
- Immunizations: The immunization schedule was updated in 2014. For a current list of required immunizations, please follow the steps below and choose "2014 new immunization requirements." The information available here will outline all immunizations needed by age and grade.
- Forms are Online! You can access the healthforms mentioned, on the school website. For all students, regardless of age, select "schools" and "high school." Under the links on the right-hand side, select "health department," and on the righthand side you can find forms under "Contents."

Data privacy policy (Release of student information)

he school will observe the following policy to conform to the requirements of the Family Rights and Privacy Act of 1974:

Student pictures and identifying names will be printed in the school yearbook and all district publications and given to the local news media on occasions that warrant it. However, any student, or the student's parent, if the student is under the age of 18, may request that his/her picture not be published or information released in the news media or school publications. Requests are to be made in writing to the building principal. Participation in any group picture implies consent for release of picture with name.

This policy does not apply to pictures taken by the news media or information gathered and printed by the media. Due to yearbook publication deadlines, students must submit requests prior to December 15.

The school district recognizes its responsibility in regard to the collection, maintenance and dissemination of pupil records and

the protection of the privacy rights of students as provided in federal law and state statutes.

Directory information means information contained in an education record of a student which would not generally be considered harmful or an invasion of privacy if disclosed. It includes, but is not limited to: the student's name, address, telephone listing, date and place of birth, major field of study, participation in officially recognized activities and sports, weight



and height of members of athletic teams, dates of attendance, degrees and awards received and the most recent previous educational agency or institution attended. This information is public data on individuals. Directory information does not include personally identifiable data which references religion, race, color, social position or nationality.

The parent or adult student has the right to refuse to permit the designation of some or all of the categories as directory information with respect to that particular student. If the parent or student notifies the school district that they don't want this information designated as directory information, the classification remains private.

Indoor air quality notice

lencoe-silver lake school district is proud to be taking a leadership role in providing a safe, comfortable and productive environment for our students and staff so that we achieve our core mission – educating students. Our school will follow the EPA guidance to improve our indoor air quality by preventing as many IAQ problems as possible, and by quickly responding to any IAQ problems that may arise. Staff and parents can also obtain information about school facility construction, maintenance and housekeeping practices, chemicals used, mold and HVAC related information, chemical producing academic subjects, and pesticide and herbicide applications to determine the extent to



which school activities contribute to a child's symptoms by contacting the school.

2017-2018 school year asbestos notification

ederal legislation (asbestos Hazard Emergency Response Act – AHERA) requires each primary and secondary school in the nation to complete a stringent inspection for asbestos and to develop a plan of management for all asbestos-containing building materials. Glencoe-Silver Lake Public Schools have a goal to be in full compliance with this law. As a matter of policy, the district shall continue to maintain a safe and healthful environment for our community's youth and employees.

Brady Flaherty, Dashir Management Company, is the person designated as Asbestos Program Manager for our schools. He can be contacted at 320-510-0825. An operation and maintenance program is in place through which we respond to our ACBM on a continuing basis.

In keeping with this legislation, all buildings owned or leased by Glencoe-Silver Lake Public Schools were inspected by EPA-accredited inspectors and samples were analyzed by an independent laboratory. Based on the inspection, the

school prepared and the state approved a comprehensive management plan for handling the asbestos located within its buildings safely and responsibly.

During the last school year, Glencoe-Silver Lake Public Schools conducted the following with respects to its asbestos containing building materials: Boiler rooms and tunnels at Lincoln and High School – pipes and glove bagging

Federal law requires a periodic walk-through (called "surveillance") every six months of each area containing asbestos. In addition, the law requires all buildings to be re-inspected three years after a management plan is in effect. Musser Environmental Consulting, Inc. will accomplish this under contract. Areas where management issues are noted during inspections and surveillances have been, and will continue to be, dealt with promptly.

Short-term workers (outside contractors, i.e., telephone repair workers, electricians and exterminators) must be provided information regarding the location of asbestos in which they may come into contact. All short-term workers shall contact Brady Flaherty, Dashir Management Company, 320-510-0825, before beginning work in order to be given this information.

Glencoe-Silver Lake Public Schools has a list of the location(s) and type(s) of asbestos containing materials found in the school buildings and a description and time-table for their proper management. A copy of the Asbestos Management Plan is available for review in the District Office. Copies are available at 25 cents per page. Employment and services criminal history background check notice to parents

he school district has adopted a policy, the purpose of which is to promote the physical, social, and psychological well-being of its students. Pursuant to this policy, the school district shall seek criminal history background checks for all applicants who receive an offer of employment with the school district.

The school district also shall seek criminal history background checks for all individuals, except enrolled student volunteers, who are offered the opportunity to provide athletic coaching services or other extracurricular academic coaching services to the school district, regardless of whether compensation is paid. These positions include, but are not limited to, all athletic coaches, extracurricular academic coaches, assistants, and advisors. The school district may elect to seek criminal history background checks for other volunteers, independent contractors, and student employees.



Minnesota school districts responsible for identification of students with disabilities

n response to the individuals with Disabilities Education Improvement Act (IDEIA), Minnesota Districts must demonstrate that "all children with disabilities, including children with disabilities attending private schools, regardless of the severity of their disabilities and who are in need of special education and related services, are identified, located and evaluated." This responsibility extends to children with disabilities who receive their formal education in a private school. Home schooled children are considered private school children in Minnesota.

Upon request, the Glencoe-Silver Lake Public School District will provide information to concerned parents on specific disabilities including information about the educational or behavioral manifestations of each disability. Parents who believe their child may indeed have a disability may request procedural information on how to arrange for an evaluation through the Glencoe-Silver Lake Public School special education staff.

Parents of students who are evaluated and are found to be eligible for special education services will become part of a team that will develop, implement, and monitor the effectiveness of an Individualized Education Plan to meet the identified needs of their children.

If you have any questions or would like to receive information about specific disabilities or evaluation, please contact the principal of the school building your child would attend in the Glencoe-Silver Lake Public School District if he/she were not being home schooled. Bullying is expressly prohibited on school district property or at school-related functions

A safe and civil environment is needed for students to learn and attain high academic standards and to promote healthy human relationships. Bullying, like other violent or disruptive behavior, is conduct that interferes with students' ability to learn and teachers' ability to educate students in a safe environment. The school district cannot monitor the activities of students at all times and eliminate all incidents of bullying between students, particularly when students are not under the direct supervision of school personnel. However, to the extent such conduct affects the educational environment of the school district and the rights and welfare of its students and is within the control of the school district in its normal operations, it is the school district's intent to prevent bullying and to take action to investigate, respond, remediate, and discipline those acts of bullying which have not been successfully prevented. The purpose of Policy 514, Bullying Prohibition Policy, is to assist the school district in its goal of preventing and responding to acts of bullying, intimidation, violence, and other similar disruptive behavior.

An act of bullying, by either

an individual student or a group of students, is expressly prohibited on school district property or at school-related functions. This policy applies not only to students who directly engage in an act of bullying but also to students who, by their indirect behavior, condone or support another student's act of bullying. This policy also applies to any student whose conduct at any time or in any place constitutes bullying that interferes with or obstructs the mission or operations of the school district or the safety or welfare of the student, other students, or employees.

The misuse of technology including, but not limited to, teasing, intimidating, defaming, threatening, or terrorizing another student, teacher, administrator, volunteer, contractor, or other employee of the school district by sending or posting email messages, instant messages, text messages, digital pictures or images, or website postings, including blogs, also may constitute an act of bullying regardless of whether such acts are committed on or off school district property and/or with or without the use of school district resources. (Refer to Policy 524, Internet Use Policy Development, for more information). Any person who believes he

or she has been the victim of bullying should report the alleged act(s) immediately to an appropriate school district official. The harassment report form is available from the principal of each building or in school offices, but oral reports will be considered complaints as well.

Notice concerning use of pest control materials

he GSL school district utilizes a licensed, professional pest control service firm for the prevention and control of rodents, insects, and other pests in and around the district's buildings. Their program consists of:

- 1. Inspection and monitoring to determine whether or not pests are present, and whether any treatment is needed;
- 2. Recommendation for maintenance and sanitation to help eliminate pests without the need for pest control materi-
- 3. Utilization of non-chemical measures such as traps, caulking and screening; and
- 4. Utilization of EPA-registered pest control materials when needed

Pests can sting, bite, cause

contamination, damage property, and spread disease; therefore, we must prevent and control them. The longterm health effects on children from the application of such pest control materials, or the class of materials to which they belong, may not be fully understood. All pest control materials are chosen and applied according to label directions per Federal law.

Information about the scheduling of interior pest control inspections and possible treatments is available by contacting Brady Flaherty, Dashir Management Company, at 320-510-0825. Similar information about the scheduling for application of herbicides and other materials to school grounds is also available by contacting Mr. Flaherty.

Parents of students may request to receive prior notification of any application of a pest control material, should such an application be deemed necessary on a day different from the days specified in the schedule.



Community Education and Early Childhood and Family Education classes, as well as elementary and secondary activities, will not be held when school is closed due to inclement weather. When school is two hours late, there will be no morning ECFE preschool or classes. For more specific information, including cancellation of extra-curricular activities, parents can call 864-2499 and then press "1," or call the individual building activities lines. Please don't call the schools to find out early closing information. This ties up the phone lines so that emergency calls can't get through.

Generally, school will be in session if it is felt that the buses can make their routes in relative safety. However, when weather conditions are questionable, the district's road conditions are checked and a determination is made as to whether or not to start late, dismiss school early, or close.

Even if school is in session, parents are asked to assess their particular situation to determine whether or not it is safe for their child(ren) to attend school on a particular day. During inclement weather, parents may take their child(ren) home at any time during the day by reporting to the principal's office in the building the child(ren) attend(s).
