Approve Change in Speech/Language Pathologist hours for 2017-18 school year

Resolution Establishing Combined Polling Place(s) for Multiple Precincts and Designating Hours During Which the Polling Places Will Remain Open for Voting for School District Elections Not Held on the Day of a Statewide Election

Member Lindeman motioned for the adoption of the following resolution:

RESOLUTION ESTABLISHING COMBINED POLLING PLACES FOR CERTAIN MULTIPLE PRECINCTS AND DESIGNATING HOURS DURING WHICH THE POLLING PLACES WILL REMAIN OPEN FOR VOTING FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board of Independent School District No. 2859, State of Minnesota, as follows:

- 1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The board hereby confirms those precincts and polling places so established by those municipalities.
- 2. Pursuant to Minnesota Statutes, Section 205A.11, the board may establish a combined polling place for several precincts for school elections not held on the day of a statewide election. The following combined polling places are hereby established to serve the precincts specified for all school district special and general elections not held on the same day as a statewide election:

The School District has established five combined polling places for stand-alone school elections:

Glencoe City Center

1107 11th Street East Ste.112, Glencoe

City of Glencoe; and Glencoe Townships; and in the City of Biscay: and Hassan Valley Township, McLeod County

Silver Lake Auditorium

320 Main Street W, Silver Lake

City of Silver Lake; and Hale, Rich Valley, Hutchinson and Winsted Townships; McLeod County; and Stockholm Township; Wright County

New Auburn City Hall

8402 4th Avenue, New Auburn

City of New Auburn; and Green Isle and New Auburn Townships; Sibley County

Plato Fire Hall

112 2nd Avenue N.E., Plato

City of Plato; and Helen and Bergen Townships; McLeod County; and Young America Township; Carver County

Brownton Community Center

310 2nd St. N., Brownton

City of Brownton; and Penn, Sumter, Collins and Round Grove Townships; McLeod County

- 3. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections not held on the same day as a statewide election between the hours of 10:00 o'clock a.m. and 8:00 o'clock p.m.
- 4. The clerk is directed to file a certified copy of this resolution with the county auditors of each of the counties in which the school district is located in whole or in part within 30 days after its adoption.
- 5. As required by Minnesota Statutes, Section 204B.16, Subdivision 1a, the clerk is hereby authorized and directed to give written notice of new polling place locations to each affected household with at least one registered voter in the school district whose school district polling place location has been changed. The notice must be a non forwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate County Auditor, who shall change the registrant's status to "challenged" in the statewide registration system.

Superintendent Sonju recommends establishing the polling places, setting poll hours, and adopting the Resolution Establishing Combined Polling Place(s) for Multiple Precincts and Designating Hours During Which the Polling Places Will Remain Open for School District Elections Not Held on the Day of a Statewide Election. The motion for the adoption of the foregoing resolution was duly seconded by Director VonBerge.
