


Governor Newsom Issues Framework for Reopening Schools Throughout the State

Following the release of new state guidance for the reopening of schools announced by Governor Gavin Newsom, all California counties on the official COVID-19 monitoring list will begin the 2020-21 school year with distance learning.

As of today, San Bernardino County remains on this list and will follow the state's recommendations that all public, charter and private schools within our county's 33 school districts will offer distance learning to more than 406,000 students in the county as school begins in the fall.

Given the current increase in confirmed COVID-19 cases across our region and hospitalizations statewide, Governor Newsom said that "safety is foundational" for how schools will reopen as we deal with the effects of the COVID-19 pandemic.

During this time of great transition, our offices have been working collaboratively with County Department of Public Health officials to assist county school districts in the development of school reopening plans. As the academic year progresses, we will continue to monitor updates from the governor's office and the California Department of Education that affect educational instruction in our county.

This summer, San Bernardino County Superintendent of Schools is proud to continue its commitment to offer substantial personal development webinars for education professionals, not only in our immediate regions, but throughout California.

Earlier this month, our annual Southern Region Student Wellness Conference was held virtually due to the ongoing COVID-19 pandemic. Despite this year's unique situation, our Innovation and Engagement branch went above and beyond to provide a first-class experience to more than 1,394 attendees from across California. As a participant, I was amazed to learn we had nearly 36,435 total content views that included presentations, student gallery and performances, learning lab, resource fair and brain breaks across the two-day span of the conference.

Each year this conference features impressive and engaging keynote speakers from all areas of expertise and boasts a wide offering of breakout sessions designed to empower and elevate participants knowledge of key areas in education and wellness. This year's conference was truly transformative.

SBCSS and California Office of Emergency Services Partner to Provide PPE to County Districts



SBCSS Business Support Services and Warehouse staff are proud to serve all 33 school districts throughout our county.

Steady progress is being made with the allocation of personal protective equipment (PPE) to all 33 school districts and charter schools within San Bernardino County. With Governor Newsom's recent mandate of having all schools that are on the state-monitoring list begin their 2020-21 academic school year with a distance learning model, the safety of our valued employees and staff while accessing our facilities remains a top priority, therefore, providing PPE equipment is of vital importance.

Our Business Support Services Procurement and Warehouse staff have been working diligently on this project by sorting, packaging and coordinating the distribution of the equipment to our districts and charter schools. Within the past month, the Support Center has received a 60 day supply of PPE that includes seven cases of thermometers, 10 pallets of adult disposable masks, 12 pallets of adult cloth masks, 15 pallets of face shields and 53 pallets of hand sanitizers.
