## IX. PRESENTATIONS

- A. Departmental Metrics Data Review: Dr. Bachenheimer and Departmental Supervisors [\(attached\)](#)

Mrs. Martin thanked everyone for the detailed presentations and especially the articulation work with the middle schools. She mentioned if having Geometry first, do students have enough of an algebra background to be successful in Geometry and with state assessments

Dr. Bachenheimer indicated that he and Dr. Russo perform a thorough evaluation for any program and that he and Dr. Russo make any necessary adjustments, if needed.

- B. Referendum Planning: Architect, Michael Bieri [\(attached\)](#)

Mr. Usami asked when would the bonds be sold?

Mr. Bieri said there are advantageous times to sell the bonds. Typically, it would be done in coordination when construction will start since that is the biggest expense. He would also coordinate with bond counsel and financial planner with a drawdown schedule which will determine when to sell the bonds. He added that interest rates at the time could be a determining factor.

### COMMENTS FROM THE PUBLIC

Citizens are invited to make comments regarding agenda items and are limited to three minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise, sign in and state their name, town of residence, and which agenda item(s) they are referencing.

Luke Dargan of Hillsdale spoke at graduation as the executive president. He mentioned that he highlighted many positive aspects at Pascack Valley. He did not address, but values most is the transparency between students and teachers. He indicated that his midterm and final grades did not reflect his previous performance in class or level of understanding. He indicated that recalling information from 5 or 10 months is extremely difficult without proper preparation. He commented that he and another student developed a public policy presentation to understand other students' opinions about the exams. He commented that they met with Dr. Bachenheimer and presented the goals and opinions on midterms and finals and he said the data was anecdotal. When they asked for the data that Dr. Bachenheimer and the supervisors had compiled, he

refused. He indicated that he conducted a survey covering various course and grade levels with over 150 students responding. He mentioned that 66.2% experienced a decline in grades and 12.3% saw no change. He commented that mental health and confidence were harmed as well. He said the dip in grades put VP and PH students at a disadvantage compared to other students in the college admissions process and merit money. He believes that the exams are outdated and the district needs to follow the lead of Northern Valley, Bergen Academies, Indian Hills, Westwood, Bergen Tech, Cresskill, Tenafly, and many more.

Samantha Forest of Hillsdale commented the large material packets provided in preparation for midterms and finals are intimidating to review as students are still in the process of learning some of the material. She indicated that some teachers provide the packets only days before the exam that leads to cramming for the exam. She mentioned that in science the packets without answers are provided days before the exam which led to students leaning on others that impacts them negatively. She commented that she did not see an improvement in the exam schedule this past year although administrators indicated that there would be an improvement. She said they are led to believe that is in preparation for higher education. She indicated that they surveyed 163 sophomores, juniors and seniors and 82.2% said the exams do not increase their long term knowledge learned in the class, 74.8% said that the teachers do not teach them techniques and strategies to succeed in the exams, 78.8% said that the teachers do not review the material after the exam. She commended the English and History departments for providing a superfluous amount of corrections and one to one time on how to improve performance. She commented that these exams diminish one's hard work during the semester. She said the exams are wrecking students' averages and they are not accomplishing what they are intended to do. She added that she and Luke would be forwarding the survey results along with their statements.

Michael Fox of Hillsdale commented that three alumni and National Honor students in the audience never had their grades go up after a midterm or final despite the 92% who experienced an increase stated by Ms. Bilotti. He mentioned that he has communicated about this topic with Ms. Bilotti starting in February 2023. He indicated that information he requested in the past and did not receive has been shared tonight. He said he was taken back by this. He mentioned that this year students missed seven days plus review time for these exams. He cited the English and Social Studies teachers who do not give those exams had a great impact on students which he shared with Ms. Bilotti and Dr. Bachenheimer. Mr. Fox commented that students expressed that they do well during the year in Math and Science, however it's the two exams that have negatively affected their grades. He mentioned that he has not heard too much about math. He suggested running the midterm and final in two course periods to avoid disruption of seven days plus review time. He said students need teacher contact time. He mentioned that in science grades are negatively impacted. He commented that unit tests have been positive and displays progression throughout the year. He said for AP a midterm is a good idea in preparation for the AP exam. He referenced Northern Valley and the use of quarterly exams which he saw great value instead of a 10-month exam. He said he has yet to find a college that has a 10-month exam.



He mentioned a feedback day which he commended teachers, but he believed it to be an impossible task in a short amount of time. He commented that there was no feedback and any feedback given is difficult for students to retain as they head off for the summer.

Michelle Ferrara of Woodcliff Lake mentioned the possible merger of the theater programs due to auditorium construction and the resignation of Allison Andresini, theater director at Hills. She commented that she appreciates the plan for the program to continue, but it is problematic as rehearsals will be from 4-6 and weekends rather than the traditional 6-9. She said this would not allow students to participate in sports and other activities. She indicated that her son would not be able to participate in cross country or track with the proposed schedule. She indicated that others would be in a similar situation. She suggested that parents and students of the program come up with a solution.

Ms. Bilotti commented about the theater program indicating that the principals and the Lupfers are discussing the concerns and potential solutions. She mentioned that the sharing of space is needed due to the work on the Hills auditorium. Also, the new director may have a different philosophy than the previous director. Ms. Bilotti thanked the students and Mr. Fox for sharing information with the Board which the administration will review. She indicated that the talented administration and teaching staff have written questions for state assessments, so they do not take this lightly. She indicated that they have questions about the syllabus, providing sufficient study skills and study guides, if there is enough time for feedback after the assessment. She said they want students to enter college as prepared as possible. Ms. Bilotti commented that they are looking to see if GPAs are affected by the exams and how it compares to other surrounding districts. She mentioned that some districts are not willing to share that information, but there are other ways to obtain it. She added that GPAs in the district have risen in the past four years as it has throughout the area. They want to see if the pattern is similar to other surrounding districts. She indicated that they will continue to monitor the effectiveness of the study skills assessment as two of the alumni spoke to that. She asked the two to share their findings with her. She mentioned that midterms and finals accounted for 20% of grades which most of the state were following. The district changed to 15% last year and this year it went down 7.5%/5%. AP is not considered since it is weighted higher. Some of the higher level math courses are 7.5%. The confusion may be attributed to how teachers set up their grade books. She appreciated the feedback from everyone and the work done by the administration.

Mr. Weaver commented that he is aware when schedules change there is an effect on participation and it isn't good. He said he does not know what solutions the administration has considered such as renting space or seeing if St. Joe's has availability. He indicated that he would be in favor of spending funds to keep the program successful. Mr. Weaver said he was confused about what is true about final exams. He mentioned that his son said finals make up 15% of the grade, but Mr. Weaver is not sure that is correct. He added that there are different numbers mentioned tonight and he does not know which is correct. He asked that facts about the exams be presented to the Board in the future so they may have a clear

understanding. He thanked the alumni for sharing their experiences which is very important for the Board to hear since it's a perspective that they do not have. Mr. Stankus is on the Curriculum Committee and indicated that they will look at the concerns. He said they are constantly evolving and not resistant to change.

**XIV. OLD BUSINESS**

Monthly Suspension Report ([attached](#))

Ms. Calderone attended a seminar sponsored by the Bergen County Workforce Development on May 30th that focused on construction trades and Pascack Hills and Valley students were in attendance. She mentioned that the session lasted two hours and included representatives from Eastwick, Ramapo, Bergen Community College, and local business people in construction who spoke about careers. She said parents and students believed there is a stigma attached to trade jobs and that is unfortunate. She commented that the district needs to do a better job of supporting these students. She thought there was a post secondary committee in the past and she would like to see it resurrected.

Mrs. Martin said it became part of the curriculum committee and Mr. Stankus concurred and said he would bring it up to Dr. Bachenheimer and have a presentation delivered.

Mr. Luisi commented that trades are critical to the country and to our students. He suggested that we make it a requirement for vendors to offer internships.

Mrs. Martin mentioned that in our communities that college is pushed on the kids. She said there needs to be a message that there is honor in going into the military and the trades. The first question that kids are asked is where they are going to college.

Ms. Calderone concurred by saying that during the fashion show they mention the colleges the students will be attending. She mentioned that the representatives of Eastwick and others indicated that they do have tables, but students veer away because they don't want to be seen going to those tables.

Mrs. Martin suggested a separate night for the trades.

Mr. Weaver said it's an important conversation to have and continue. He indicated that there was discussion about having a committee, but nothing has materialized. He mentioned that the new schedule was to increase students taking electives. He would like to see a comparison of electives taken prior to the new schedule versus the new schedule. He also would like to see what electives in the trades are offered. And if there are opportunities to grow that and what trades internships are offered. He recommended that the Board make that a goal and he would support and participate in a committee.

Mr. Stankus mentioned that he started teaching in New York City where they have Regents and every student was pushed towards those exams. He indicated that the Curriculum Committee is trying to find a middle ground with exams. He said in an AP course, students are aware of what is expected and how prepared they are before they get to the final exam. He believes exams are necessary for preparation yet others believe it's perspiration. He said he is confident they will find that middle ground and what is best for the students.

Mr. Weaver appreciated Mr. Stankus' perspective. He asked about the preparation for what? He commented that Mr. Fox mentioned there is no ten month exam in college. He indicated that a high school final exam may be more demanding than a college final.

Mr. Stankus indicated that an AP course for a year is comparable to a college course for a semester.

Mrs. Martin disagreed as she said in college a semester course meets three days a week for three and a half weeks while in high school, they meet five days a week for ten months.

Mr. Stankus said the themes are revisited throughout the year. Mrs. Martin said it depends on the class.

Mr. Weaver mentioned going on college visits with his son and how difficult the requirements can be. However, the students attending the school mentioned that they do not need to attend the large lectures since they can get the information online. He indicated that the college experience is different based on the program and the student as opposed to high school where the expectations are generally the same for all. He added there are kids who are not going to college and they may need the personal touch that Mr. Fox referenced.

Mrs. Martin left at 9:22.

Mr. Stankus indicated that there are variations in expectations in the district and they are trying to figure it out and so are colleges since they are evolving.

Ms. Stephans commented that once they receive the data then they can make an informed decision.

Ms. Bilotti said there is data to support administering midterms and finals. She mentioned that high achieving districts are discussing this since there is no clear answer for each district. She indicated that they come up with the right solution for the students in order for them to have the most success. She said they will provide the numerical data in the next presentation. She mentioned that there will be additional learning labs next year and they will take a deeper look into their effectiveness as well as study guides. She indicated that they will discuss career and tech ed in electives and internships at the next curriculum meeting. She commented that she was impressed with the offerings the district provides and she believes that the Board will be as well. Mr. Stankus wanted to make that impact does not necessarily mean stop, but modify. He added that it may depend on the subject as they vary from each other.

Ms. Stephans mentioned that some of the students do well throughout the year and then do terribly on the midterm or final.. It is devastating to the students. She would like to see anonymous course evaluations where students have a voice.

Mr. Weaver said perception is the student's reality. He said they need to get the right information and that everyone has it.

Mr. Luisi would like to know why a student who is doing well fails an exam. He said it's either preparation or nerves. He commented that he is concerned if preparation is the reason because that is part of being successful at work. He agreed with Mr. Stankus that modification is good, but not to go to either extreme.

Mr. Weaver commented that if everyone does not do well on the exam, was the assessment true to the expectation. Was it true to what was taught?

Mr. Weaver asked if athletic appointments are on July 17, how can coaches work with athletes from July 1 to 17.

Ms. Bilotti indicated that past practice has allowed coaches and assistant coaches from prior year to meet with athletes until the appointments are made. If a head coach stepped down then an assistant coach would step in.

Mr. Weaver asked if this is district practice or in a regulation.

Ms. Bilotti said she conferred with the attorney last year and he said it was acceptable practice. She indicated that they are working to have the appointments done earlier in the year like in May or June.
