CHANGES TO BIDDING REQUIREMENTS:

Item 1 – The mandatory Job walk has been canceled in its entirety. There will not be a job walk or a requirement for a job walk for the bid.

Item 2 – Replace the bid form with the following attached bid form. This change removes the verbiage "Bid Package 02 Demolition and Grading" from the top of the form and adds a section for the bidder to write in the bid package being submitted.

Item 3 - Replace section 01 10 10 00 Scope of Work in its entirety and replace with the attached section 01 10 1000 Scope of Work. This document is correcting a format error in the original document. The original track changes have been removed.

Once the Trade Contractor has received the Notice to Proceed, the Trade Contractor shall diligently study and work with Construction Manager and other Trade Contractors to build a realistic Trade Contractor Baseline Schedule for the purpose of outlining the entire scope of Work and to complete the Work in the time specified in the Agreement. By submitting this bid, Trade Contractor has thoroughly studied this Project, the labor market, and the supply chain market for materials and equipment that are necessary to complete the Project and Trade Contractor agrees that the Contract Time for this Project is adequate for the timely and proper completion of the Project. Further, Trade Contractor has included in the analysis of the time required for this Project, Rain Days, Governmental Delays, and the requisite time to complete Punch List.
- 5. It is understood that the District reserves the right to reject any or all bids and/or waive any irregularities or informalities in this bid or in the bid process. The Trade Contractor understands that it may not withdraw this bid for a period of ninety (90) days after the date set for the opening of bids.

Time is of the essence regarding the completion of the Project in the Contract Time and within the Milestones set forth in the Outline Schedule, therefore, in the event the bidder to whom the Contract is awarded fails or refuses to post the required bonds and return executed copies of the Agreement form within five (5) calendar days from the date of receiving the Notice of Award, the District may declare the bidder's bid deposit or bond forfeited as damages.
- 15. The bidder declares that he/she has carefully examined the location of the proposed Project, that he/she has examined the Contract Documents, including the Plans, General Conditions, Supplemental Conditions, Addenda, and Specifications, and read the accompanying instructions to bidders, and hereby proposes and agrees, if this proposal is accepted, to furnish all materials and do all work required to complete the said work in accordance with the Contract Documents, in the time and manner therein prescribed for the unit cost and lump sum amounts set forth in this Bid Form. The undersigned bidder hereby acknowledges and agrees that such bidder shall not be entitled to any price increase to the Total Cash Purchase Price set forth above on account of or due to any external factors including, but not limited to, inflation, labor shortages, and/or supply chain issues/shortages.
- 16. <u>DEBARMENT</u>.  - a. Intentionally or with reckless disregard, violated any term of a contract with the District;
- b. Committed an act or omission which reflects on the Trade Contractor's quality, fitness or capacity to perform work for the District;

- c. Committed an act or offense which indicates a lack of business integrity or business honesty; or
- d. Made or submitted a false claim against the District or any other public entity. (See Government Code Sections 12650, et seq., and Penal Code Section 72)
- 17. <u>DESIGNATION OF SUBCONTRACTORS</u>. GENERAL SCOPE OF WORK AND PROVISIONS (APPLICABLE TO ALL BID PACKAGES)

SECTION 01 10 10 - 00 SUMMARY OF WORK

1. GENERAL

1.1. SUMMARY

The General Scope of Work and Provisions Section is applicable to all Bid Packages and outlines the standard requirements that must be performed on a daily basis. In case of conflict between the General Scope of Work and Provisions and the Bid Package Specific Scope of Work, the most stringent shall apply.

1.2. RELATED DOCUMENTS AND PROVISIONS

TRADE CONTRACTOR shall review all Contract Documents for applicable provisions related to the provisions in this document, including without limitation:

- 1.2.1. General Conditions;
- 1.2.2. Special Conditions;
- 1.2.3. Submittals; and
- 1.2.4. Temporary Facilities and Controls.

1.3. SUMMARY OF WORK COVERED BY CONTRACT DOCUMENTS

- 1.3.1. Work of the total Project is planned to be accomplished by dividing the total work amongst the various prime contracts, each of which is identified by a "Bid Package" number and title. The various prime TRADE CONTRACTORs are referred to herein as "Trade TRADE CONTRACTOR" or "TRADE CONTRACTOR".
- 1.3.2. Demolition of existing and reconstruction of new outdoor athletic facilities including buildings and site work, earthwork and utilities, lighted synthetic turf sports fields, fencing, landscaping, irrigation, bleachers and press box and construction necessary for the Elsinore Elementary School New Administration Building Increment 1 Project.

1.4. CONTRACTS

Each BID PACKAGE or TRADE CONTRACTOR shall Perform the Work under a single, fixed-price Contract.

1.5. WORK BY OTHERS

The Plans may make reference to "By Others" in which various design disciplines are referring to other disciplinary sheets (Fire Sprinkler to Plumbing, Structural and Architectural, etc.). This shall not mean that work is being performed "By Others". The entirety of the project, with the exception of Owner Furnished Owner Installed equipment, shall collectively be performed by the TRADE CONTRACTORS. TRADE CONTRACTORS shall refer to all Specification Section 10 10 10 Summary of Work.

1.6. CODES, REGULATIONS, AND STANDARDS

- 1.6.1. The codes, regulations, and standards adopted by the State and federal agencies having jurisdiction shall govern minimum requirements for the Project. Where codes, regulations, and standards conflict with the Contract Documents, these conflicts shall be brought to the immediate attention of the District and the Architect.
- 1.6.2. Codes, regulations, and standards are as published effective as of date of bid opening, unless otherwise specified or indicated.

1.7. EXAMINATION OF EXISTING CONDITIONS

- 1.7.1. TRADE CONTRACTOR shall be held to have examined the Project Site and acquainted itself with the conditions of the Site or of the streets or roads approaching the Site.
- 1.7.2. Prior to commencement of their Work, TRADE CONTRACTOR shall survey the Site, existing buildings and new improvements to observe existing damage and defects such as cracks, sags, broken, missing or damaged glazing, other building elements and Site improvements, and other damage. This shall include work in place performed by other TRADE CONTRACTORs.
- 1.7.3. Should TRADE CONTRACTOR observe cracks, sags, and other damage to and defects of the Site, other TRADE CONTRACTORs work and adjacent buildings, paving, and other items not indicated in the Contract Documents, TRADE CONTRACTOR shall immediately report same to the District and the Construction Manager.

1.8. TRADE CONTRACTOR'S USE OF PREMISES

- 1.8.1. If unoccupied and only with District's prior written approval, TRADE CONTRACTOR may use the building(s) at the Project Site without limitation for its operations, storage, and office facilities for the performance of the Work. If the District chooses to beneficially occupy any building(s), TRADE CONTRACTOR must obtain the District's written approval for TRADE CONTRACTOR's use of spaces and types of operations to be performed within the building(s) while so occupied. TRADE CONTRACTOR's access to the building(s) shall be limited to the areas indicated.
- 1.8.2. The Project Site although fairly large, is extremely limited and is not able to accommodate storage of materials and equipment unless immediately being utilizes for the TRADE CONTRACTOR's work. TRADE CONTRACTOR shall coordinate just in time deliveries and keep material stored in an offsite location to be paid for by the TRADE CONTRACTOR. CONSTRUCTION MANAGER shall designed certain areas of the site for material/staging laydown which will be provided on a priority basis.
- 1.8.3. If the space at the Project Site is not sufficient for TRADE CONTRACTOR's operations, storage, office facilities and/or parking, TRADE CONTRACTOR shall arrange and pay for any additional facilities needed by TRADE CONTRACTOR, at no expense to District.
- 1.8.4. TRADE CONTRACTOR shall not interfere with others use of or access to occupied portions of the building(s) or adjacent property.
- 1.8.5. TRADE CONTRACTOR shall maintain corridors, stairs, halls, and other exit-ways of building clear and free of debris and obstructions at all times.
- 1.8.6. No one other than those directly involved in the demolition and construction, or specifically designated by the District or the Architect shall be permitted in the areas of work during demolition and construction activities.
- 1.8.7. Refer to Exhibit 02 of the Contract Documents in regards to Construction Staging and Logistics Plan.

1.9. TRAFFIC CONTROL

1.9.1. Each TRADE CONTRACTOR shall provide all traffic control flagmen, barricades, safety barriers, and any street controls or closure permits as necessary and

pertaining to their scope of work and as required by local Ordinance.

1.10. PROTECTION OF EXISTING STRUCTURES AND UTILITIES

- 1.10.1. The Drawings show above-grade and below-grade structures, utility lines, and other installations that are known or believed to exist in the area of the Work. TRADE CONTRACTOR shall locate these existing installations before proceeding with excavation and other operations that could damage same; maintain them in service, where appropriate; and repair damage to them caused by the performance of the Work. Should damage occur to these existing installations, the costs of repair shall be at the TRADE CONTRACTOR's expense and made to the District's satisfaction.
- 1.10.2. TRADE CONTRACTOR shall be alert to the possibility of the existence of additional structures and utilities. If TRADE CONTRACTOR encounters additional structures and utilities, TRADE CONTRACTOR will immediately report to the District for disposition of same as indicated in the General Conditions.
- 1.10.3. Specific TRADE CONTRACTORs may be required to identify existing utilities via pot holing. Refer to respective Bid Packages specific Summary of Work for pot holing/identification of existing utility requirements.

1.11. UTILITY SHUTDOWNS AND INTERRUPTIONS

- 1.11.1. TRADE CONTRACTOR shall give the District, through the CONSTRUCTION MANAGER, a minimum of five (5) days written notice in advance of any need to shut off existing utility services or to effect equipment interruptions. In no instance shall utilities be allowed to be shutdown during regularly school operation hours (7AM-4PM Monday through Friday). Each Contractor shall account within their base bid any premium time required to work Saturday's or before our after school hours in order to perform utility shutdowns. District will set exact time and duration for shutdown, and will assist TRADE CONTRACTOR with shutdown. Work required to re-establish utility services shall be performed by the TRADE CONTRACTOR.
- 1.11.2. TRADE CONTRACTOR shall obtain District's written approval as indicated in the General Conditions in advance of deliveries of material or equipment or other activities that may conflict with District's use of the building(s) or adjacent facilities.

1.12. STRUCTURAL INTEGRITY

- 1.12.1. TRADE CONTRACTOR shall be responsible for and supervise each operation and work that could affect structural integrity of various building elements, both permanent and temporary.
- 1.12.2. TRADE CONTRACTOR shall include structural connections and fastenings as indicated or required for complete performance of the Work.

1.13. FIELD MEASUREMENTS, LAYOUT AND SURVEY

- 1.13.1. The District will hire an independent professional surveyor to perform surveying services for certain phases of the project as scheduled by the Construction Manager. Example; project start, building pad certification, building slab elevation verification and as required by the Construction Manager. Each Bid Package is required to provide their own survey during the course of their work in order to ensure required grades and elevations are met. Third party survey verification shall be requested in writing 72 hour prior the requested survey date to the Construction Manager.
- 1.13.2. The District provided Survey will include existing topography, area of work limits/property line set-backs, utility points of connection, building grid lines and building corners, and third party verification of TRADE CONTRACTOR's scope of work, if in question or necessary by the CONSTRUCTION MANGER. This shall not relieve each TRADE CONTRACTOR from performing field measurements, layout, or providing additional survey as may be required to perform their scope.

1.14. COORDINATION WITH CONSTRUCTION MANAGER

- 1.14.1. The District has hired a CONSTRUCTION MANAGER to coordinate and oversee the work. TRADE CONTRACTOR shall coordinate directly with the CONSTRUCTION MANAGER and TRADE CONTRACTOR's in order to accomplish the work.
- 1.14.2. TRADE CONTRACTORs shall direct all Project Correspondence and Documentation through the CONSTRUCTION MANAGER, unless directed otherwise. TRADE CONTRACTOR shall have no direct communications with the OWNER and/or ARCHITECT, unless written permission is provided.
- 1.15. COORDINATION WITH OTHER PRIME AND SUB TRADE CONTRACTORS

1.15.1. Coordination between all TRADE CONTRACTORs, subcontractors, material suppliers, Owner, Site Staff, CONSTRUCTION MANAGER and jurisdictional agencies is required and necessary for the successful completion of the work. TRADE CONTRACTORS shall properly coordinate with other TRADE CONTRACTORS and subcontractors continuously in order to accomplish the work.

- 1.15.2. TRADE CONTRACTORs shall proceed with the work in accordance with the most current Bid Schedule, Monthly Update Schedule, 3 Week Look-Ahead Schedule or as directed by the CONSTRUCTION MANAGER. In no event shall a TRADE CONTRACTOR install their work so as to prevent follow-on contractors from the installation of their work. If necessary and due to failure to properly coordinate the work, TRADE CONTRACTORs shall remove, relocate, and reinstall work that is not in accordance with the schedule and/or has impacted other TRADE CONTRACTORS from completing their work.
- 1.15.3. TRADE CONTRACTORs are responsible to provide coordination and layout for the other TRADE CONTRACTORS when components are scheduled to attach or are directly affected by the elements of work within their respective contract.

1.16. HOURS OF WORK

- 1.16.1. Generally, the Hours of Work will be Monday through Friday between the hours of 7:00AM and 4:00PM, with the exception of work which may be required to be performed after hours, such as bridge construction and/or utility shutdowns. In no event shall work be performed outside of the local jurisdictional hours without express approval from the CONSTRUCTION MANAGER.
- 1.16.2. City of Buena Park allowable construction hours:

Monday through Friday: 7:00AM to 7:00PM Saturday: 8:00AM to 5:00PM

Sundays & Federal Holidays: No Work Allowed without

Authorization

1.17. MOBILIZATION

- 1.17.1. TRADE CONTRACTORS are responsible for the mobilization and ALL necessary move-ins as required by CONSTRUCTION MANAGER's Bid Schedule, to perform the work. Refer to Specification Section 01 32 13 and Exhibit 01 for scheduling requirements.
- 1.18. SWPPP / BEST MANAGEMENT PRACTICES

- 1.18.1. The implementation of general Erosion Control Measures and/or BMP's shall be performed by select TRADE CONTRACTORs as specified in the Summary of Work Section 10 10 10. However, all TRADE CONTRACTORS all best management practices associated with work under their bid package
- 1.18.2. BMP's associated with each respective TRADE CONTRACTORs scope of work may include, but is not limited to: providing concrete washout pits, dust control, and cleaning of streets due to trucking on or off the site, controlling water runoff into storm drains or offsite during concrete placement and clean-up operations and containment of all toxic material as required by law. Clean-up and dispose of all temporary washout pits, and other temporary facilities as required and legally dispose of all waste material.
- 1.18.3. Any TRADE CONTRACTOR found in violation of SWPPP requirements will pay all penalties or fines due to any violations issued to the Owner for this TRADE CONTRACTOR's failure to meet requirements by the State or other Government agencies for non compliance with the State or Federal Clean Water Act or other regulations.

1.19. DAILY HOUSEKEEPING / CLEAN-UP

- 1.19.1. Continuous housekeeping and daily cleanup is mandatory for all TRADE CONTRACTORS. TRADE CONTRACTORS shall place construction debris in designated debris boxes and remove debris from site at contractor's own expense prior to the end of the work day or as directed by the CONSTRUCTION MANAGER. All debris boxes will be identified for this contracts use, and containers shall be kept free of graffiti at all times.
- 1.19.2. TRADE CONTRACTORS shall properly dispose of all trash, unused material, debris, and waste at the end of each work day. Failure to perform this task daily, will cause the Owner to exercise its right to self perform work and direct the clean up by others at the expense of the TRADE CONTRACTOR upon immediate verbal notice or written notice.
- 1.19.3. Clean-up and dispose of all temporary washout pits, and other temporary facilities as required and legally dispose of all waste material. Bid Package will pay all penalties or fines due to any violations issued to the Owner for this Bid Package's failure to meet requirements by the State or other Government agencies for non-compliance with the State or Federal Clean Water Act or other regulations.

1.20. NOISE

1.20.1. TRADE CONTRACTOR shall manage all personnel in order to reduce excessive noise levels caused to adjacent residents, businesses, public, and other onsite personnel. This shall not only apply to care taken during the work activities, but shall also apply to personnel during arrival, breaks, and end of day activities. No

excessive shouting, profanity, or the use of radios or other broadcasting devices shall be allowed on or surrounding the project.

1.21. DAILY REPORTS

- 1.21.1. Each TRADE CONTRACTOR shall provide a Daily Report which shall be submitted to the CONSTRUCTION MANAGER.
- 1.21.2. Daily Report must at a minimum identify the TRADE CONTRACTOR by name, date, deliveries, inspections, a description of work completed and in progress, and a listing of all TRADE CONTRACTOR and subcontractor personnel.
- 1.21.3. Daily Reports shall be on the form specified by the CONSTRUCTION MANAGER through Procore and shall be uploaded to Procore properly at the end of each day.
- 1.21.4. Daily Reports are considered part of the contract scope of work and as such, failure for TRADE CONTRACTOR to provide current and accurate Daily Reports may prevent the release of progress payments until corrected.

1.22. AS-BUILT DOCUMENTS

- 1.22.1. Each TRADE CONTRACTOR shall provide and maintain as-built documents on a regular basis.
- 1.22.2. CONSTRUCTION MANAGER will provide electronic access, via ftp site, PDF plans to all TRADE CONTRACTORS. TRADE CONTRACTORS shall "redline" plans as it relates to their specific scope of work at the end of each work week for verification by the CONSTRUCTION MANAGER. Should TRADE CONTRACTOR not provide weekly as-built updates, progress payments will not be processed until corrected.

1.23. LABOR RATES

- 1.23.1. TRADE CONTRACTOR shall provide to the CONSTRUCTION MANAGER prior to the approval of any Progress Payments a detailed breakdown of the labor wage rates of all it's employees and subcontractor's employees that will be performing work on the project. At a minimum, Labor wage rates shall be broken down in accordance with DIR General Prevailing Wage determinations.
- 1.23.2. This requirement is in addition to and separate from Prevailing Wage, Certified Payroll and Compliance Monitoring Unit and the District's Labor Compliance Program.

1.24. TESTS AND INSPECTION

1.24.1. Except as set forth below, the District will pay for fees, costs and expenses to complete the initial tests/inspections of portions of the Work as required by law, code or regulation, provided that such tests/inspections are conducted and completed at a location within a one hundred (100) mile radius of the Site. The foregoing notwithstanding, if the portion(s) of the Work subject to tests/inspections is/are not ready for such test/inspection at the time indicated in the Contractor's notice under Article 26 or if upon completion of such test/inspection, the portion(s) of the Work subject to such test/inspection do not meet or exceed the minimum requirements of such test/inspection, the Contractor shall be solely responsible for the payment of all fees, costs or expenses arising out of or related in any manner to subsequent tests/inspections of such portion(s) of the Work. Notwithstanding the District's payment of fees, costs or expenses for conducting initial tests/inspections, if any actions or failures to act of the Contractor or person or entity providing or performing Work under the direction or control of the Contractor require tests/inspections to be conducted over a period of more than eight (8) hours per day by any single person or on weekends/holidays, the Contractor shall be solely responsible for the payment of fees, costs or expenses which result from test/inspection services which exceed eight (8) hours per day by any single person or on weekends/holidays. If any tests/inspections are conducted outside a one hundred (100) mile radius of the Site, the Contractor shall be solely responsible for all costs, fees or expenses to conduct and complete such tests/inspections conducted at such location, including without limitation, costs to complete such tests/inspections and travel, meal and related expenses.

1.25. SAFETY

- 1.25.1. TRADE CONTRACTORS and subcontractors are solely responsible for all safety precautions and programs in connection with work under their agreement.
- 1.25.2. The requirements of Cal/OSHA, state, county and city laws, statutes, regulations, codes, ordinances and order of those governing bodies having jurisdiction over the work, including the OCIP specific safety specifications listed in Appendix D establish the minimum safety guidelines for the project. In the event of a conflict or inconsistency, the most stringent standard will govern.

1.26. EXCAVATIONS, SOILS, AND SPOILS

1.26.1. <u>Excavation:</u> All Bid Packages are responsible for the excavation, backfill, compaction and any import/export required for each bid package to complete their own work.

- 1.26.2. Spoil Disposal: All Bid Packages are responsible for the legal removal and disposal to an offsite location of all excavation and other spoils generated on the site by their own work. Open Trench Protection: Provide all trenches and/or excavations required for the installation of work of this Bid Package (including de-watering and erosion control), backfilled and properly compacted flush to adjacent existing grades (with approved backfill and bedding materials imported if necessary at no additional cost to the Owner). - 1.26.4. Re-establishing Existing Grades: The grade at completion of this scopes work cannot exceed .10 +/- of certified grade. Verify all excavations are back to existing grades with Construction Manager at completion (within 24hrs) of each excavation and prior to other Contractors start of new activities. Contractor will be responsible for any extra grading activities due to lack of grade verification with Construction Manager.
