# **PERSONNEL:** (Susan Taylor, Chairperson)

#### A. Action Items:

On a motion by Susan Taylor, seconded by Len DiGiacomo, the following action items were approved. Roll call vote: Unanimous. Motion carried.

- 1) Recommend the Board accept the resignation of Andrea Gleeson, Special Education Teacher, effective June 30, 2018.
- 2) Recommend the Board accept the retirement of Denise Seger, Aide, effective June 30, 2018.

### **FINANCE: (Eve Waite, Chairperson)**

#### A. Discussion Item:

1) NJ DOE Finance Memo and Guidance dated July 13, 2018 – District state aid for the 2018-2019 school year will be reduced by \$107,562. Documents must be submitted to County Office by August 7, 2018 with Board approval no later than August 1, 2018. Mrs. Smith and Mr. Forney explained information contained in the documents. It was noted that these state aid reductions will take place over the next 7 years, increasing with each year. Mrs. Smith informed the board that this will be the last year that the state will be allowing emergency funding for decreased state aid.

#### **B.** Action Items:

On a motion by Eve Waite, seconded by James Southard, the following action items were approved. Roll call vote: Unanimous. Motion carried.

1) Recommend the Board approve following resolution (2018-7-1) regarding a reduction in state aid: line item reductions in response to the NJ DOE Budget Notification Memo dated July 13, 2018 and the NJ State Guidance Document:

WHEREAS, the New Jersey Department of Education has issued a memo and guidance dated July 13, 2018 (18-19-1) to all school districts indicating an adjustment in funding for the Fiscal Year 2018-2019, and

WHEREAS, the aforementioned memo directs school districts to the Homeroom website for details of the change in state aid \$107,562 (18-19-2)

WHEREAS, Board action must be taken before August 1, 2018, and

WHEREAS, the Eastampton Board of Education had discussed in detail the options available to the district and has implemented a plan to address the state aid reduction,

NOW THEREFORE BE IT RESOLVED, the Eastampton on Board of Education does hereby authorize the district's School Business Administrator to reduce the following line items to address the reduction in state aid consistent with all applicable laws and regulations.

2) Recommend the Board approve the submission of an application for Emergency Aid to the County Office of Education pursuant to the language included in the FY2019 Appropriations Act for \$107,562.

Mrs. Douglas asked for an explanation of Extraordinary Aid. Mrs. Smith replied that it is a form of state aid for per pupil special education expenditures that exceed a certain monetary threshold. Mr. Forney indicated that the aid is pro-rated based on how many districts apply and the amount received is only a percentage of the actual district expenditure.

With no further business to discuss, the Board meeting was adjourned at 7:17p.m. on a motion by Glenn Forney, seconded by Susan Taylor. All in favor.
