#### Per Meal Fee:

The management fee is a cents-per-meal management fee comprised of two parts. For each student meal served, the fee is \$0.1464 cents. For each meal equal served (all non-reimbursable income divided by a meal equal factor of \$1.00) the fee is \$0.0959 cents. The sum of these two fees is the total management fee. CPI for renewal is 0%.

### **PUBLIC PARTICIPATION:**

- -Mrs. Day made a statement in favor of Mr. Duckett for the position of Superintendent/Principal.
- -Mrs. Taylor provided an update of the Superintendent/Principal search process. She mentioned that three board members had a very productive meeting with the ETEA recently about this subject. Mrs. Taylor commented that the entire process was a rewarding experience for members of the search committee as well as the whole board. The board felt that they had three exceptional candidates and would be deliberating in executive session later in the evening. Mrs. Taylor indicated that the board expected to make a decision by early May.
- -Mr. Geary commented that the busses are not stopping at the stop sign on Student Drive. He also asked if the DOT had sanctioned Student Drive and Learning Lane. Mr. Forney responded that he believed that they were sanctioned; however, the area between the two roads is the property of the Board of Education and not subject to DOT oversight.
- -Mrs. Derienzo asked for a status on the outsourcing of the CST. Mrs. Smith indicated that third party companies did not provide an acceptable quote. Dr. Krastek mentioned that discussion about shared services is an ongoing process between districts and will continue to be point of discussion throughout the year.

Any pending or anticipated litigation or contract negotiation in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer (if pending or anticipated litigation, the matter is: (if contract negotiation, the nature of the contract and interested party is)
Under certain circumstances, if public disclosure of the matter would have a potentially negative impact on the District's position in the litigation or negotiation, this information may be withheld until such time that the matter is concluded or the circumstances no longer present a potential impact);

Any deliberation of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party as a result of an act of omission for which the responding party bears responsibility;
