Helping Students Overcome Learning Challenges

Not all students learn at the same pace. While some may have no trouble learning their multiplication tables or sounding out new words, others might still struggle with math or reading skills even after reviewing the material several times.

Recognizing that each student has individual needs and challenges, The Learning Academy provides one-on-one tutoring services to help students address and overcome their individual learning difficulties. These tutoring sessions are provided free to any student, kindergarten through grade 8, in Burlington County.


Each student who attends the program works with his or her tutor to develop an individualized plan that addresses the areas of academic difficulty and sets specific academic goals.

How the Program Works

After an assessment of the individual student's learning style, he or she is matched with a tutor based on the student's needs and the tutor's area of expertise. Once the student and tutor are matched, one-on-one learning sessions are scheduled in either 30-minute or 60-minute increments.

Tutoring Sessions Conducted by Education Professionals

All tutoring sessions are conducted by teachers who have earned a bachelor's degree from an accredited college or university. Additionally, all tutors are formally trained for The Learning Academy's program.

At The Learning Academy, our main goals are to increase students' academic skills, improve their self-esteem and self-confidence levels, and better their overall attitude toward school and learning.

Recognizing the influence that parents have with their children, we can also help teach parents how to more effectively support and assist their children in study and homework skills.

During the course of each student's program, our tutors communicate with each child's teacher(s) as often as possible. This helps keep the teacher(s) informed on the student's progress, as well as any lingering challenges that still need to be addressed.

Additionally, The Learning Academy hosts monthly Family Reading Nights and Family Book Discussion Nights for families with young children to help get children excited about reading and learning. Here, both parents and children can participate and learn together. Monthly parent seminars are held to help parents work with their children academically, creating an effective and efficient support system for both parties involved.
