WARRANT FOR 2011-2012**

**Deliberative Session February 5, 2011**

**To the inhabitants of the Cooperative School District in the Towns of Fitzwilliam, Gilsum, Richmond, Roxbury, Sullivan, Swanzey and Troy qualified to vote in the District Affairs:**

You are hereby notified to meet at the **Monadnock Regional Middle/High School on Saturday, the 5<sup>th</sup> day of February, 2011 at 10:00 o'clock in the forenoon** for the purpose of hearing an explanation of the following subjects and to carry on any discussion or debate with respect thereto, with said subjects to be open to amendment:

**NOTICE: School District Officers will be elected at the second session of the Annual Meeting of the Monadnock regional School District on March 8<sup>th</sup>, 2011 in accordance with the statutory election procedures adopted by a vote of the District on March 11, 1996. The School District Warrant for the election of School District Officials will be posted in accordance with Revised Statutes Annotated (RSA) 40:13 in each of the District's member Towns.**

**The polls will be open to voters in their towns of residence on March 8, as follows:**

**Fitzwilliam – Town Hall, 11 am-7pm  
Gilsum – Gilsum Elementary School, 1pm-7pm  
Richmond-Veterans Hall, 11am-7pm  
Roxbury-Meeting House, 6:30pm-mid-meeting  
Sullivan-Town Hall, 11am-7pm  
Swanzey-Christian Life Fellowship Church, 8am-7pm  
Troy-Troy Elementary School, 10am-7pm**

**ARTICLE ONE:** Shall the Monadnock Regional School District raise and appropriate in the operating budget not including appropriations by special warrant articles, which will be voted on separately, totaling \$32,910,000, (\$970,000 is required for federal grants and nutrition grants that are funded by separate State and Federal revenues)? Should this article be defeated, the default budget will be \$34,941,251 which is the same as last year with certain adjustments required by previous action of the Monadnock Regional School District by law; or the governing body may hold one special meeting, in accordance with Revised Statutes Annotated (RSA) 40:13, X and XVI, to take up the issue of a revised operating budget only. The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE TWO:** Shall the voters of the Monadnock Regional School District raise and appropriate the amount of \$191,500.00 for the purpose of funding a district wide all-day kindergarten program? The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE THREE:** To see if the Monadnock Regional School District will vote to raise and appropriate the sum of \$1,343,641.00 for renovations at the Monadnock Regional High School-Middle School as recommended by the New England Association of Schools and Colleges (NEASC), and further to authorize the withdrawal of \$267,204 from the 1975 Capital Reserve Fund and \$130,000 from the 2009 School Building Capital Reserve Fund for this purpose? The balance of \$946,437 is to come from general taxation. This a Special Warrant Article in accordance with RSA 32:3 VI. This will be a non-lapsing warrant article per RSA 32:7 and will not lapse until the maintenance projects are complete or June 30, 2014 whichever is earlier. The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE FOUR:** To see if the Monadnock Regional School District will vote to raise and appropriate the sum of \$148,300.00 for repair of health and safety related maintenance items (Phase II of the Sprinkler/Fire Alarm System) at the Mount Caesar Elementary School. This a Special Warrant Article in accordance with RSA 32:3 VI. This will be a non-lapsing warrant article per RSA 32:7 and will not lapse until the maintenance projects are complete or June 30, 2014 whichever is earlier. The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE FIVE:** Shall the Monadnock Regional School District vote to raise and appropriate the sum of \$0.00 to be added to the 2003 School Building Maintenance Expendable Trust previously established by Article #3 of the 2003-04 Warrant? The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE SIX:** Shall the Monadnock Regional School District vote to raise and appropriate the sum of \$50,000 to be added to the 2003 Special Education Expendable Trust Fund created under Article #5 of the 2003-04 Warrant? The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE SEVEN:** To see if the Monadnock Regional School District will vote to raise and appropriate the sum of \$34,845 to reduce the Fiscal Year 2010 general fund deficit pursuant to RSA 189:28-a. The School Board supports this article. The Budget Committee supports this article. (Majority vote required).

**ARTICLE EIGHT:** To see if the Monadnock Regional School District will vote to raise and appropriate the sum of \$1,200,000 for the purpose of building a Multi-Purpose Room at Mt. Caesar Elementary School in Swanzey. This is a special Warrant Article in accordance with RSA 32:3 VI. This will be a non-lapsing warrant article per RSA 32:7 and will not lapse until construction is complete or June 30, 2014, whichever is earlier. This is a petitioned warrant article. The School Board does not support this article. The Budget committee does not support this article. (Majority vote required).

**ARTICLE NINE:** To see if the district will approve the proposed boundary line agreement between the school district property boundary in Troy and the abutting land North of School Street, as kept on file at the Superintendent's office and take any other action in relation thereto. (Majority vote required).

**ARTICLE TEN:** Shall the Monadnock Regional School District receive and approve the reports of the agents, auditors, committees and officers chosen as printed and distributed in the Annual Report? (Majority vote required).

**ARTICLE ELEVEN:** To listen to opinions of a purely advisory nature with regards to the conduct of school affairs for the ensuing year. (Majority vote required).
