4. October through February: Execute all elements of the communications plan

- a. Create and deliver content through media outlets, such as:
 - i. Newspaper
 - ii. Radio
 - iii. Home mailings
 - iv. Etc.
- b. Organize and attend/host informational sessions regarding the building project for various audiences, such as:
 - i. Select Boards of Each Town
 - ii. Parent Groups
 - iii. General Voter Community
 - iv. Etc.

5. January/February: Develop Warrant in Plain English **MOTION:** B. Tatro **MOVED** to support the CRC Goals for 2022/23 as presented. **SECOND:** S. Peters. **VOTE:** Unanimous for those present. **Motion passes.**
