Introduction

The following items shall be considered part of the Contract Documents and shall be included in same when Construction Contract is executed. Changes made by Addenda shall take precedence over original Documents. Any changes which may affect construction or proper installation of materials, equipment, or fixtures, not specifically mentioned in this Addendum, should be brought to the attention of the Architect before submitting bid. Otherwise, such conditions, if found later to exist, must be worked out in an acceptable manner without additional cost to the Owner. General Contractors are hereby advised to call to the attention of all subcontractors, changes which may affect their work.

Acknowledge receipt of this Addendum by inserting its number and date in the proper blank appearing on the Bid Form. Failure to do so may disqualify the Bidder.

General

- 1) Ref: Instruction to Bidders, Section 3.3: Contract time shall be 150 days.
- 2) Pre-Bid Meeting Minutes (see attached)
- Contractor shall provide soil stabilization matting, final grading of topsoil, and hydroseeding of any areas disturbed or damaged from the work required to complete the project.
- 4) No additional cost will be allowed for Contractor means and methods of construction.
- 5) Time is of the essence. Notice to Proceed will be issued following the Pre-Construction meeting. Shop drawings shall be provided by Contractor immediately following the Notice to Proceed.
- 6) No additional coast will be allowed for any price increases to products and materials approved for the project.
- Contractor shall be responsible for any surveying or other methods required to locate out field fencing. Fencing shall be located exactly where the existing fence was previously located.

- 8) Contractor shall be responsible for design and direct burial of concrete light poles and is responsible for determining and verifying all soil conditions at light pole locations.
- 9) Contractor shall have a representative on site for all deliveries of equipment, materials, etc. for the project and shall coordinate deliveries with school personnel.

Electrical

- 10) Ref. Sheet E2.1 Electrical Riser Diagram & Panel Schedules:
 - a. It is the intent of the contract documents the existing electrical service entrance equipment and branch circuity be disconnected and removed to aloe for all new service entrance equipment as indicated. The existing equipment rack may be reused. Contractor shall provide and install new equipment structure where necessary to accommodate footprint of new equipment. Contact Entergy and pay any fees incurred.
 - b. Ref. Panel DP:
 - i. Change 2-60A 2P spare breakers to 2-100A 2P spare breakers.
 - ii. Add 1-20A 1P CB to feed 20A 125V receptacle indicated on Riser adjacent to Panel DP.
 - iii. Add 1-20A 1P CB refeed existing load (verify on-site)
 - iv. Add 1-30A 1P CB refeed existing load (verify on-site)
 - v. Add 1-30A 2P CB refeed existing load (verify on-site)
- 11) Prior Approvals: Subject to compliance with the provisions of the Contract/Documents, Specification, the following manufacturers may be substituted.

LIGHT FIXTURE MANUFACTURER

A GEO Elite CLIR Series, Musco TLC-LED Luminaires

Contractor shall note that prior approval is by manufacturer's name only. Contractor shall ensure that the products used in preparation of his proposal and proposed to be used on this project, is equivalent to that specified in appearance, performance, size, installation type, and shape. Any material found to be not equivalent to the specified will be rejected, Prior approval of one manufacturer does not automatically prior approve any subsidiary company, parent company and/or sister company and their associated products.

- Soil stabilization matting and redressing of topsoil to repair ruts and other construction-related site damage should be considered.
