

BOARD REPORT

BOARD OF TRUSTEES MEETING September 14, 2020

The Brownwood ISD (BISD) Board of Trustees met for a regular session meeting on Monday, September 14, 2020 at 6:30 p.m. The session was called to order by Board President, Michael Cloy. BISD Trustee, Tim Jacobs, gave the invocation and Board President, Michael Cloy, led the Pledge of Allegiance.

INSTRUCTIONAL FOCUS

Brownwood ISD Superintendent, Dr. Joe Young, noted that face-to-face and remote numbers were holding steady at 82% and 18% respectively. Remote teachers are beginning to work with parents who have plans for their kids to return to face-to-face learning. Dr. Young reported that parent liasons are splitting time between the elementary and middle school campuses to assist with any attendance issues. Instructional coaches have been added this year and are working to assist remote teachers with Google Classroom, grade level meetings, and provide additional instructional support. Beginning of the year testing and assessments have been administered and district interventionists are processing the data to find any possible gaps that were created due to the unforeseen COVID-19 circumstances this past spring.

SUPERINTENDENT'S REPORT

Dr. Young provided an update on the district's COVID-19 response plan, noting that Nurse Helen Lacy continues to do a great job working with the health department on contact tracing and identifying any possible close contacts. Data from each case is being collected and analyzed to help the district make the best decisions regarding how close contacts are determined and how to safely narrow down who is sent home when a positive case is confirmed.

Enrollment/Transfer Report: Dr. Young reported that enrollment numbers are down, primarily at the pre-k, kindergarten, and elementary levels. Enrollment in grades 7-12 is up from 2019. Though some drop in enrollment was expected due to COVID-19, Dr. Young cautioned that it does affect the amount of money the district has to work with. Transfers in from other districts are up. Dr. Young noted that our expanding programs, certification options, and the various choices that we offer at the secondary level are likely contributing to those additions.
