BOARD OF TRUSTEES MEETING September 9, 2019

The Brownwood ISD (BISD) Board of Trustees met for a regular session meeting on Monday, September 9, 2019 at 6:30 p.m. The session was called to order by Board President, Michael Cloy. Tim Skaggs, Pastor of Coggin Avenue Baptist Church, gave the invocation. Coggin Intermediate School 5th grade student, Jolea Chambers and 6th grade student, Kaylie Valdez, led the Pledge of Allegiance.

INSTRUCTIONAL FOCUS

Brownwood ISD Deputy Superintendent, Liesa Land presented the Instructional Focus update. Land reported the improvement in the overall district's grade from TEA, which is now a B. Land also provided a brief summary of the TEA grades for each campus including score improvements and new distinction designations at Brownwood Middle School and Northwest Elementary School. Although many of the scores had increased, Land indicated there is still work to be done and continued room for improvement.
