The Brownwood ISD Board of Trustees met for a regular session meeting on Monday, February 8th at 6:30 p.m. The regular session was called to order by Board President, Michael Cloy, who also gave the invocation. Brownwood Middle School students, Alexis Dossey, Darby Crysler, and Annabeth Hood led The Pledge of Allegiance.

SUPERINTENDENT'S REPORT

- Brownwood ISD received a thank you letter from The Ark for a donation towards helping battered women.
- Texas Department of Agriculture (TDA) Audit (Food service) Brownwood ISD Superintendent, Dr. Joe Young informed the board that there was only one finding and it was a printer problem that has now been corrected. "The impressive part to me was that the auditor that came from the TDA mentioned how personable our workers were with the students and how they seemed to know the kids and would talk to them as they came through the line," reported Young.
- Head Start had two audits. A November audit came back with no findings, and the
 preliminary report from a financial audit February 1st 5th which examined Region 14
 and 15 also had no findings. The final report is expected later next month. "I am very
 pleased with the Head Start program," said Dr. Young. "I know that it's new to
 Brownwood ISD and Mrs. Land [Brownwood ISD Deputy Superintendent] and her group
 have done a great job making sure that it is run correctly."
- Dr. Young reported positively on events of the past month that included the
 Brownwood Economic Summit, the Board Retreat, and the Region 15 Superintendents
 meeting that was hosted at Brownwood ISD. Young and Brownwood ISD School
 Resource Officer, Fred Bastardo, attended Active Threat Training with police and school
 officials and administrators from the area to discuss how they would come together,
 respond, and be prepared to handle an incident if it were to come up within the county.
- The Lady Lions have made the basketball playoffs. The next game is scheduled for Tuesday, Feb. 16th at 7:00 p.m. in Breckenridge.
- Dr. Young mentioned that Brownwood ISD Community Relations Coordinator, Charles
 Musgrove would be attending the Texas School Public Relations Association (TSPRA)
 conference at the end of February and would be receiving an award for Brownwood ISD
 PR/Advertising materials that were submitted.
- An organizational meeting for the new UIL District will also be held at the end of February in Abilene.
- The report concluded with a reminder that the Bluebonnet Relays are the 4th and 5th of March, Spring Break is the following week (March 7-11), and the next board meeting will be Tuesday, March 15th.

DISCUSSION & ACTION ITEMS

PUBLIC HEARING: Texas Academic Performance Report (TAPR) – Dr. Young provided the board with his observations relating to the data contained in the report.

Liesa Land provided additional details to the board regarding the TAPR report, specifically outlining resources that have been used to address efficiency. Land also noted the drop-out rate is down and our attendance rate district-wide is up. The complete report will be posted

online and also includes accreditation and accountability information (Brownwood ISD met all required standards), performance objectives, and information on violent and criminal incidents.

POLICY READING: Policy FFA(Local): Wellness and Health Services was reviewed with the board. The board will review the update and it will be an action item at the next board meeting.

ACTION ITEM: Dr. Steve Kelly requested permission, on behalf of the Central Texas Veterans Memorial Committee, to move the World War I Memorial currently located in front of the Family Services Center (old BHS Building), to the new site of the Central Texas Veterans Memorial located in the 36th Division Memorial Park. Tim Jacobs made a motion to approve the relocation and Brad Jetton seconded. The motion passed unanimously.

ACTION ITEM: The board was presented with two 2016-2017 school calendar options that were thoroughly discussed, worked on, and approved through the Site-Based Committee. Dr. Young briefly explained the process the committee worked through to come up with the calendars and noted that student instruction, as well as what is best for kids remained driving forces behind the calendar options. Dr. Young also reported that a new change by the state to require completed *minutes* rather than *days* opened up some new options for committee members to consider. The committee unanimously approved two calendar options and Dr. Young also provided results of a subsequent poll taken throughout the district that showed overwhelming support for calendar option 1. A motion to accept calendar 1 was made by Tim Jacobs, seconded by Diane Thompson, and approved unanimously.

CONSENT AGENDA: Items on the Consent Agenda were approved unanimously as presented with a motion by Eric Evans and a second by Diane Thompson.
