Great news, Winston County Schools are once again planning to serve FREE meals this Summer. Participation in this program is voluntary, however, your participation in our CNP programs helps make this possible. This Summer program will allow us to provide meals to children ages 18 and under, **FREE OF CHARGE**, throughout the months of May, June, July, and August. Students are qualified to receive these meals regardless of financial status. These meals will be available by either local pickup or delivery by school bus. **Every two weeks**, participants will receive a total of 10 breakfasts and 10 lunches. Some items, such as milk, may be provided in bulk quantities (gallons). In the event your household has additional children under the age of 18, they may also qualify for this program. Please contact your local school lunchroom manager for further information. Meal pick-up/delivery time will be **each scheduled Thursday (see below) between 4:00 and 5:30 pm**. In order to prepare, our District needs an accurate count of those who wish to participate.
