April 29, LCAP DELAC/DPAC Draft LCAP presented for input from DELAC and DPAC-No questions were generated, therefore no written response from the Superintendent was required.

May 3-28, LCAP Parent and Staff Input Survey

May 12, 2021-Administrative Team: Site leaders, Principals, Special Education Coordinator and members of the District Administrative Team met to review the draft strategies selected and the input gathered from all stakeholder groups to further develop the Expanded Learning Opportunity Plan.

May 13, 2021-Bargaining Units: The district met with SUTA and CSEA leadership to share the DRAFT - SUSD Expanded Learning Opportunities Grant Plan and gather their input. Budget information was reviewed with both groups.

May 25, 2021, the SUSD Expanded Learning Opportunities Grant Plan will be presented to the Board of Trustees for their input and approval.

June 7-28 2021, LCAP Public Comment (community members, students, parents, classified staff, certificated staff, and administrators)

June 8, LCAP Public Hearing (Utilized as public comment period for ESSER III Plan)

June 29, LCAP Board Approval-Local Indicators were presented in conjunction with the LCAP adoption. Board adopted the budget this same meeting as the adoption of the LCAP.

October 25, 2021-Plan presented to the Governing Board for approval

A description of how the development of the plan was influenced by community input.

Community input for the Extended Learning Opportunities Plan (ELO), the Local Control Accountability Plan (LCAP) and the ESSER III Plan included parents, staff, students representing, children with disabilities, English learners, homeless students, foster youth, and migratory students. Administrators, teachers, classified staff, and both bargaining partners also provided input for these two plans. In addition, both plans were presented to the Governing Board for public comment and approval. There were no available representatives for children who are incarcerated, Tribes or Civil Rights Organizations. The district evaluated its stakeholder engagement opportunities and determined that (Civil Rights Groups/ Tribes/ Advocates) are neither present nor served by the district. The input from all of these stakeholder groups influenced these plans, and by extension the ESSER III plan in the following manner:

- Parents expressed a desire to see summer programs expanded to include access to an increased number of students. Both the ELO and LCAP plans include action items regarding the provision of summer programs for both 2021 and 2022. Input from parents highlighted the need for safety practices, protocols and supplies in order to make in person summer programs safe. Parents also expressed interest in providing students with both a distance-learning and in-person option for summer school credit recovery and go ahead classes at the high school level, which were implemented in 2021 and are planned for 2022. Lastly, parent input also addressed the provision of professional learning for Trauma Informed Practices for classified, certificated, and management staff at both summer programs and for the upcoming school year.
- Teachers, administrators and classified staff provided input for the need for additional paraprofessional support to students and teachers during the summer program sessions for grades K-3, with services prioritized for English learners and students with disabilities as part of the ELO plan. LCAP input from teachers and administrators was about providing additional, supplemental leveled reading, writing, math, and language development materials and professional learning to support identified instructional strategies. The LCAP was further influenced by input from staff (teachers, support personnel, classified, administrative) that addressed the need to continue to provide intervention services, in particular math interventions, and access to Visual and Performing Arts at all levels. All staff concurred with the need to provide social and emotional learning lessons for all students, districtwide.
- The bargaining unit's input influenced the LCAP in regards to the need to provide social, emotional, and mental health services to students and access to Visual and Performing Arts at all levels. Those services will continue in the LCAP and will include the addition of a curriculum for Social-Emotional Learning.
- Administrators input included the need for diagnostic, progress monitoring, and benchmark assessments to monitor student learning. This included the recommendation for the purchase of a data dashboard that centralizes academic and behavioral data for teachers, site leaders, and district personnel and after School Tutoring services for students in grades 3 to 12.
- Students provided input that influenced the LCAP by communicating their interest in participating in band, sports, art, drama, and dance. Students also influenced the plan to provide Distance Learning options for summer programs for 9-12. Many students also expressed that they felt the schools were doing a great job of helping them learn.
- During ESSER III specific input sessions parents provided input for the need to support Social Emotional Learning and provide positive behavioral support for students; provide Trauma informed and resiliency training for staff; additional Bilingual Instructional Aides in grades 1-3; additional after school programs; voice amplifiers or wireless mics for teachers; clear masks for primary teachers; increase STEM/CTE classes; elementary school clubs and intervention in math services.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
