



MWHS STUDENT PARKING RULES & REGULATIONS 2024-2025

Student parking is a **privilege** that may be suspended or revoked for failing to follow the rules and regulations. Please read the following guidelines for parking at Magnolia West High School.

- Students must have a valid 2024-2025 Magnolia West Parking Tag in order to park on school property.
- Students must have enough credits to be considered in 10th-12th grade to purchase a Parking Tag.
- Double spots will only be allowed with MWHS Admin approval (some vehicles may not qualify)
- The following documentation is required to obtain and keep a parking permit.
 - Copy of valid Texas Driver's License with student's name listed.
 - Printed Proof of Insurance with the student driver's name listed as an insured driver for the vehicle(s) or a letter from the insurance agency indicating the student is insured on the policy.
Electronic images and/or photos on a phone will not be accepted.
 - Completed parking application signed by both the student **AND** parent/guardian.
 - Maintain participation in the MISD Mandatory Drug Testing program and submit the testing Consent Form- signed by both the student **AND** parent/guardian.
 - **Payment** can be made via **debit/credit card** when the application and documents are returned. Parking spaces are sold in the amounts of \$50 for a general spot, \$75 for preferred and \$100 for premium.
 - General spots are sold in numerical order and preferred/premium spots are student choice

Student parking privileges may be suspended or revoked for the following:

- Excessive absences or tardies. Three (3) or more absences and/or tardies to the student's 1st class may result in disciplinary action by the administrators. Excessive and repeated absences and/or tardies can result in a loss of parking privileges. Parking fees will NOT be reimbursed if parking privileges are revoked due to discipline.
- Parking a car that is not registered.
- Parking in any area except that which belongs to the student. This can include lots not designated for students, handicapped spots, fire zones, and grassy or unauthorized areas.
- Reckless driving, damaging another person's vehicle, littering or not following directives by security
- Leaving the building to go to the parking lot without permission or loitering in the parking lot before, during or after school. This includes West Hour/lunch.
- Invalid or expired driver's license or insurance.

Parking tags must be placed on the rear view mirror of the registered vehicle. It is understood that anyone who is parked illegally or without permission on school property is subject to having their vehicle towed at the owner's expense.

MWHS and MISD are not responsible for stolen items or vehicle damage on school property.

3. Attach a copy of proof of insurance. (cannot be image on phone) Vehicle(s) and name of student must be listed
4. Attach a copy of current Texas Driver's License
5. Payment can be made by debit/credit card when returning this application and documents.

Mandatory Drug Testing Student Consent Form for Minor Students 2024-2025

I understand that my child will be asked to provide a urine sample for drug analysis, and I consent to such testing conducted as part of the District's drug testing policy, outlined in Magnolia ISD Board Policy FNF(Local).

I also understand that while my child cannot be compelled to produce a specimen, the giving of a specimen when requested by the District is a condition of my child's continued participation in the identified extracurricular activities or maintaining a parking permit.

I understand that if a test of my child's specimen reveals an unexplained presence of a drug, the District may take action against my child up to and including termination of participation in extracurricular activities or parking privileges.
