NOTICE OF PUBLIC HEARING

The Burbank Unified School District will hold a public hearing on March 16, 2023, to gather public input regarding the potential composition of trustee area boundaries.

The Burbank Unified School District’s Board of Education is currently elected under an “at-large” election system, where Board members are elected by voters of the entire District. On December 15, 2022, the Board adopted a resolution, signaling its intent to transition to by-trustee area elections commencing with the 2024 election cycle. In a by-trustee area election system, each Board member must reside within the designated trustee area boundary and is elected only by the voters in that trustee area.

On December 15, 2022, the District’s legal counsel, Lozano Smith, also presented information on the transition process and potential criteria for drawing the trustee area boundary maps.

On January 19, 2023, the District’s legal counsel and demographer, National Demographics Corporation, provided information on the transition process and potential criteria for drawing the trustee area boundary maps. Following the presentations, the Board held the first of two statutorily required hearings to receive input from the community on the trustee-area map creation process, pursuant to Elections Code section 10010(a)(1), prior to the drawing of draft maps.

On February 16, 2023, the District’s legal counsel and demographer provided information on the transition process and potential criteria for drawing the trustee area boundary maps. Following the presentations, the Board held the second of two statutorily required hearings to receive input from the community on the trustee-area map creation process, pursuant to Elections Code section 10010(a)(1), prior to the drawing of draft maps.

On March 16, 2023, the District’s demographer will provide information on the transition process, review the districting criteria, and present initial draft trustee area boundary maps. Following the presentations, the Board will hold the third of five statutorily required hearings in this process, pursuant to Elections Code section 10010(a)(1). This will be the first Board hearing at which the public and Board can review and comment on the draft maps and provide direction on desired any new or revised maps, and it is the Board's opportunity to narrow the draft maps from six to a smaller group of "focus" maps..
