## 2024-25 FHSCCA Parking Permit Contract

## Parking Privileges Regulations and Contract

- 1. Students must park in school-approved parking areas only. Spaces will be numbered and the pass must match the numbered space. Unnumbered spots are not assigned and vehicles parking in these spots will be towed at the owner's expense.
- 2. Permits must be displayed at all times on the inside rearview mirror facing the front windshield.
- 3. If a permit is lost or left at home, the discipline director's office will issue a temporary parking permit. This is only valid for one day.
- 4. Students cannot go to automobiles during the school day.
- 5. If a student's permit is suspended a traffic cone will be placed in their designated parking spot until the pass is reinstated.
- 6. Students may not loiter in the parking lot before or after school. Students must report to their designated area in the mornings and leave the parking lot in the afternoon. NO SITTING IN VEHICLES-If this becomes a problem the parking pass can be suspended by the administration.
- 7. Tickets will be written, and fines will be assessed by the school resource officer for parking and moving violations on campus.
- 8. Parking violations will be issued, and a fine of \$20, payable to the main office, is due within two weeks, or students will lose parking privileges, and a hold notice will be put on a report card or diploma.
- 9. Students are expected to be in Advisement by 7:15. Unexcused tardies will result in the following:
  - i. **Tardy 1-4** = Free
  - ii. **Tardy 5-6** = After school detention
  - iii. **Tardy 7-8 =** 1 day of ISS and a 5-day suspension of parking privileges.
  - iv. **Tardy 9-10** = 1 day of Saturday school and 10-day suspension of parking privileges.
  - v. **Tardy 11+** = 3 Days of OSS and suspension of parking privileges for the remainder of the semester or 20 days, whichever is longer. At the 11th tardy there will be a meeting set up with the parent after the suspension has been completed.
- 10. Cars are towed at owner's expense for the following violations:
  - i. -Any vehicle parked in a space without a student-parking permit hanging from the rearview mirror, or a vehicle parked in an un-numbered space.
  - ii. -Any vehicle parked on campus that is not parked in designated parking area with either a faculty member permit or a student parking permit.
- 11. Once a student drives on campus, he/she is considered "at school" and must check out through the front office to leave campus. Violation of this rule will result in student discipline and loss of driving privileges.
- 12. Students may not back into their parking spaces.
- 13. Students may not have any obscene or inappropriate stickers, decals, adornments, etc.
- 14. Students will not be allowed to drive to Wiregrass classes written approval by an administrator at FHSCCA. Violation will result in suspension of the student's permit at administration's discretion.

- 15. Students that are caught skipping class and leaving campus will have their parking privileges suspended. Violation will result in suspension of the student's permit at administration's discretion.
- 16. Parking is a privilege and may be revoked at any time for violations without a refund of the permit fees.
- 17. Parking permits cost \$20 a semester and \$40 for the year and are valid for the 2024-2025 school year only and must be paid with cash.
