3. Services To Helen Thackston Charter School

<u>Background</u>: Over the past several years, the LIU has provided services to the students and staff at Helen Thackston Charter School. These services have included special education transportation and services to students, as well as professional development consultation and training to staff. Despite numerous attempts of the LIU over the past several years, Helen Thackston Charter School has failed to meet its financial obligation to remit payment for services already delivered and is currently in arrears to the LIU in the amount of \$210,211.38.
