Superintendent Mastrocola informed the committee that after a comprehensive selection and interview process he was recommending Michael Knight as our new School Business Administrator. Mr. Knight will begin on July 1 with Mr. Garabedian as his mentor.

Superintendent Mastrocola informed the committee that Greater Lowell currently has 196 senior students participating in cooperative education employment opportunities as of February 28, 2019. This represents 39% of the Class of 2019 and is an increase from last year. We also have 10 junior students participating in cooperative education employment opportunities.
