REPORT OF GENERAL COUNSEL

There was no report of general counsel.

REPORT OF SUPERINTENDENT-DIRECTOR

Superintendent Mastrocola informed the committee that through our energy broker, the district procured pricing for our electricity. The district selected Direct Energy's pricing of \$.0963 per KWH. The rate is approximately \$.02 cents less that our current rate which will result in a savings of at least \$80,000 annually.

Superintendent Mastrocola informed the committee that Greater Lowell currently has 189 senior students participating in cooperative education employment opportunities as of November 30, 2018. This represents 37% of the Class of 2019 and is an increase over last year.

Superintendent Mastrocola asked for approval to accept a donation in the amount of \$1,000 from Cummings Properties of Woburn, MA to be used for the volleyball program. The donation is being made at the recommendation of one of its employees, David Furtado of Lowell.
