Superintendent Mastrocola provided an update on the SkillsUSA district competition results stating that 71 Greater Lowell students received medals at the awards ceremony.

Superintendent Mastrocola informed the committee that Greater Lowell currently has 183 senior students participating in cooperative education employment opportunities as of February 28, 2018. This represents 36% of the Class of 2018 and is down slightly from last year. He then introduced Director of Cooperation Education Stacy Bezanson to provide information on our co-op program.
