Superintendent Bourgeois informed the Committee that the SkillsUSA District competition took place today and he was just informed that of the 238 Greater Lowell competitors 50 won medals with 1 state officer candidate.

This represents 37% of the Class of 2016 and is a 3% increase compared to last year's data. Also, there are 36 junior students participating in cooperative education employment opportunities as of February 29, 2016, representing 7% of the junior class. This is a 5% increase compared to last year's data.

Superintendent Bourgeois provided an update with regard to a partnership that Greater Lowell has entered into with a non-profit to support a no cost computer programming course for homeless and disadvantaged populations.

Superintendent Bourgeois shared information regarding a \$493,385 grant Greater Lowell received to modernize equipment in our machine tech program.

Superintendent Bourgeois informed the Committee that he had been approached by the parent organization regarding a fundraising initiative. He introduced Mr. Dion, a member of the parent organization who along with Superintendent Bourgeois informed the Committee that the parent organization is starting fundraising initiatives to upgrade the football field with turf as well as new bleachers and lights.
