### REPORT OF GENERAL COUNSEL

### REPORT OF SUPERINTENDENT-DIRECTOR

Superintendent Bourgeois presented a team of students and their advisors who had recently participated in the Technical High School Math Competition. This was the first time Greater Lowell had participated in this competition and had a 3<sup>rd</sup> and 6<sup>th</sup> place finish out of 23 teams.

Football Coach Shane Abrams presented the captains of the football team and provided an update on their season.

Superintendent Bourgeois informed the committee that Greater Lowell currently has 186 senior students participating in cooperative education employment opportunities as of November 30, 2015. This represents 40% of the Class of 2016 and is a 4% increase compared to last year's data.

Assistant Superintendent/Principal Davis provided a report on a grant-funded program that Greater Lowell has been invited to collaborate on with Lowell Community Health Center to provide students with reproductive health services.

Assistant Superintendent/Principal Davis informed the committee that on December 7<sup>th</sup> Attorney General Maura Healey along with Executive Director of the Center for the Study of Sport in Society Dan Lebowitz and former New England Patriot linebacker Andre Tippett visited Greater Lowell to announce that Greater Lowell was one of the 98 schools from across the state chosen to participate in <u>Game Change: The Patriots Anti-Violence Partnership.</u> Superintendent Bourgeois asked for approval for the following donations which will be split between Automotive Collision and Automotive Technology:

Superintendent Bourgeois provided a report on the State Accountability Data that was recently released. Some of the highlights included:

- ÜGreater Lowell is a Level 1 school for the 3<sup>rd</sup> year in a row (29% of MA schools)
- ÜGreater Lowell is on target to narrowing proficiency gaps
- ÜELA MCAS CPI/SGP\* is 96.2/56 which is an 8% increase over last year
- ÜMath MCAS CPI/SGP\* is 89.0/64 which is an 11% increase over last year
- ÜScience MCAS CPI/SGP\* is 87.4/NA
- ÜGreater Lowell's graduation rate is 9.1% higher than the state average
- ÜGreater Lowell's dropout rate is less than 6 times the state average
