Mr. Kerwin and Mr. Collins provided an update on the progress of the work since the last meeting including a photo presentation so committee members could visually see the progress.

Under Other Business, Mr. Kerwin informed the committee that drawings for the repurposing of the Aramark space were complete and had been sent out for pricing. The work will be done after Consigli's contract work is complete. The other work (pool, parking lot, etc.) is being done within schedule. The MSBA project complete

date is the end of August. Consigli's contract will be extended to complete the extra work.
