## 2022-2023 PROP H HIGHLIGHTS

#### Special Education Classroom Upgrades at Oceanside High School

The scope of work included upgrading the flooring, paint, ceiling tile, lights to LED, fix/or provide new plumbing and/or fixtures, paint and/or replace wall coverings, reconfigure electrical throughout classrooms, repair any HVAC item, upgrade case work and countertops and thermal insulation as needed.



#### Gym Improvements at Oceanside High School

The scope of work included the removal and replacement the existing clerestory windows on the saw tooth roof and installation of two big fans inside of gym and site improvements.

## **Lighting Controls at El Camino High School**

This project consisted of the purchase and installation of new lighting controls in the Truax Theater. In addition, the electrical and technological upgrades were performed in order to accommodate the new lighting system.




## **Child Development Center at Surfside Educational Academy**


## **PROP H PROJECTS TAKING PLACE DURING 2023-2024**

#### **Truax Exterior Improvements at El Camino High School**

The scope of the project includes replacement of HVAC, and access ladders that are at or past their expected lifespan at the Truax Theater at El Camino High School. Due to the extremely long manufacturing time, this project was pushed into 2023-2024.

The project will be completed by winter 2024. The budget is \$437,800.00.





#### New Gym Bleachers at Oceanside High School

The scope of work consists of removing the current bleachers and replacing them with electric and ADA compliant bleachers.

The project will be completed by fall 2023 with a budget of \$566,000.00.





## **PROP H PROJECTS TAKING PLACE DURING 2023-2024**

ADA Ramp Compliance at Claire Burgener Academy

The project consists of constructing an ADA compliant ramp at the Claire Burgener Academy campus.

The project will be completed by summer 2023. The budget is \$250,000.00.

## **ONGOING PROPOSITION H SITE MODERNIZATIONS**

#### Modernization

#### San Luis Rey/Pablo Tac Elementary School

The Pablo Tac modernization will be paid utilizing Proposition H bond funds, along with other funding sources. The construction phase of the modernization for Pablo Tac School of the Arts has begun. Phase 1 will include building modernization with upgraded and new infrastructure to the northeast side of the campus including the kindergarten, first grade, and second grade buildings.

Construction will take place in a total of four phases until winter 2024. The budget for this modernization is \$32,000,000.













#### Modernization Jefferson Middle School

The Jefferson Middle School Modernization will be paid utilizing both Proposition H and Measure W bond funds. The modernization will consist of various building modernizations, required ADA upgrades, required site infrastructure upgrades, exterior improvements with special attention to redeveloping the main entry, and the construction of a new gym and multipurpose room.

The project is currently in the design phase. After the design is finalized in February 2024, the design documents will be submitted to the Division of State Architect (DSA) for approval. This process can take from five to eight months. Once approval is received from DSA, the bidding phase will begin. Construction is estimated to begin in winter 2024 with an anticipated completion of the new site by winter 2026.

The project budget is \$37,000,000.
