Michele Lasko:

It is my hope the class of 2021 can graduate as a whole. Will you be looking at different venues to accommodate that if guidelines expand yet still help with social distancing? A venue such as PNC could be an option.

Will a face shield be an acceptable form of a mask? My daughter already has a rash from wearing a cloth one.

Given the inconsistency of teacher participation in spring virtual instruction, what guidelines are being established for teachers and how will participation be evacuated?

Linda Valenza:

How will remote high school students receive instruction in each of their classes (i.e. Google Meet, Zoom, etc.)?

If a teacher experiences technology issues during class, how will they insure that the remote high school students are receiving the necessary instruction?

How will labs be handled for remote high school students (i.e. AP Chemistry, AP Physics)?

Kate King:

What is the cleaning protocol, how often will everything be cleaned?

Who is providing the cleaning supplies?

How often will bathrooms be cleaned?

Who will monitor how many students are in the bathroom at a time?

In the past, teachers had to continually complain in order to get their boards wiped and floors swept. How can we be sure the rooms will be properly maintained?

Were more custodians hired to help with the extra cleaning procedures? If not, is it even possible to clean the buildings how they need to be?

Will every room have hand sanitizer? Where else in the building will sanitizing products be kept?

Will teachers be expected to remain in the building to teach remotely? If so, how is it possible to get any deep cleaning done?

Will students be getting any live/zoom instruction for virtual learning, or will it be all pre-recorded videos?

If 100% virtual is chosen, will there be office hours for assistance?

Will virtual learners be given the same instruction/assignments remotely as their in-person peers?

How will grades be determined?

How can we assure there is accountability/credibility for virtual students?

Will virtual students be held to a schedule?

Will it be required for students to meet with teachers? Will cameras need to be on so the teacher can see the child working?

How will assessments be done virtually?

How will you assure that in-person and virtual learning is equitable?

How will we be sure to hold the students accountable for their work?

Will teachers be required to teach both hybrid and virtual models at the same time? Or will some teachers be only virtual teachers?

What is the protocol if a student or teacher is showing symptoms? Will a negative test determine if a child/teacher may return to school?

What is the procedure if a virtual student is sick or absent, i.e. make up work, etc?

Will back to school night and conferences be held in person?

Will teachers still be teaching in rooms with no windows?

WIll there be plexiglass partitions in the rooms?

How will SGOs, PDPs and evaluations be handled this year?

If you are following the Danielson model for evaluations, how is it possible to evaluate teachers while maintaining social distancing and minimizing student groupings and collaboration?

Who is providing teachers with the proper PPE? What will be provided, masks, goggles, hand sanitizer, gloves, etc?

Can teachers wear scrubs, jeans, sneakers or crocs that can be cleaned easily?

What will be the policy for students who refuse to comply with the mask rule?

How will it be handled if students pretend to cough on each other or make light of the COVID situation?

If a fight breaks out, how will that be broken up?

How are teachers supposed to help students doing work at their seats while maintaining social distance?

Is there a percentage of the population or number of cases/symptoms in people that will determine if schools would need to close to insure safety and health?

If the building is excessively hot, will school be closed for the day due to the fact that masks must be worn?

Will staff and or students require covid testing prior to in person learning?

Also, will all classrooms where students and teachers will be have air conditioning?

Jennifer Simeone:

If we opt to send our child, and after a week they cannot do it with the masks, can we go virtual? It is hard as a parent to make an all or nothing decision without testing the waters first and seeing how the kids handle how the school day will be.

Will the virtual learning, whether 3 days a week or all week be scheduled classes throughout the day?

Will the half days be followed by virtual learning in the afternoons?

Christina Reitmann:

If we opt for full time virtual learning, will our children actually be taught virtually by a teacher via Google meets all 5 days or will they receive assignments on Google to complete while the in school students receive face to face instruction?

How will district testing be handled this year?

Christine Manasse-Baptiste:

I would like to know based on the proposed school schedule with Monday/Tuesday (1/2 day) A-K, Wednesday (Virtual) and Thursday/Friday (1/2) l-Z, how are holidays being factored in, since a lot of the school holidays tend to fall on Monday or Tuesday. Will the first group still be entitled to the same amount of days/hours of in-person school?

For the 1/2 day sessions, are the parents still entitled to the wrap around program (Y-Time)?

Is there a reason that other districts propose 1/2 days Monday-Friday and our district proposes only 1/2 days M/T and T/F? Is it because of the school's capacities for students and teachers?

How is testing for students being handled for the 1st Quarter? Normally the school likes to benchmark where students are; how will that be handled to ensure that the students are assessed actually?

Deanna Longe:

As a parent of a Middle School now High School student, I felt like the virtual education my daughter received was lacking several things including structure, and no live interactive classes, only a google meets here and there and school work due by the end of day. I understand the district had a short time to put it all together and it was fine short term but long term I don't think it's beneficial for the children. Many private schools are offering live classes, where they are on video with the teachers interacting with their classmates, asking and answering questions. Now that the district has had months to come up with a better plan what is MARSD doing to improve their virtual platform for the 2020-2021 school year?

Beth and Tracy Chodkiewicz:

Date of parent/guardian Q & A session(s):

The parent/guardian Q & A sessions are scheduled for 8/12 and 8/19, while the return to school parent survey is due back by 8/12. Could these dates be adjusted, making the Q & A session prior to August 12, so that families could make a more educated decision for their children based on additional knowledge gained at the session(s)?

Teaching/Instruction:

Are teachers expected to instruct and manage both remote instruction and in-person instruction? There should be staff responsible for in-person instruction and separate staff responsible for remote instruction.

Staff concern: This is double (or more!) the prep time. My students deserve to have my full attention, whether it is remote OR in-person. One teacher should not be expected to do both with quality and rigor our students need and deserve.

Parent concern: If we should decide for 100% remote instruction for my daughter, how can we expect any teacher to provide her with full rigor and instructional support? Again, quality will be impacted, through no fault of the teacher.

Cleaning:

What are the cleaning protocols?

When will cleaning take place if teachers are in 5 full days a week?

Who is doing the cleaning?

Did you hire more custodial staff?

Will these cleaning procedures be checked and evaluated by some standard?

From my experience, bathrooms and classrooms were minimally cleaned. Often, we were unable to get simple, basic cleaning, such as new garbage bags, board washing in the classroom or soap, paper towels in the bathrooms...

Will teachers be required to clean?

As a teacher, will I be held liable if a student should get ill regardless of my cleaning?

Will effective Covid-19 disinfectants be provided to teachers and replaced, as needed?

For our daughter, how will we know her classroom will be disinfected to a high standard? One teacher may not be as thorough a cleaner as the next teacher. We do not think this task should be expected of a teacher or added to any teacher's responsibility.

Teachers should be teaching: This is their training.

Custodians should be cleaning: This is their training.

Will hand sanitizers be provided? Will they be refilled and replaced?

What about individual student materials (books, paper, pencils, chrome books, etc...)? How and when will they be sanitized?

Masks/PPE:

We are glad the District decided that ALL staff and students are required to wear masks.

Will the Code of Conduct/ Discipline Policy be amended to address proper use/wearing of masks?

Who's responsible for checking mask integrity? If it is the teacher's responsibility, is s/he held liable if there is exposure or illness amongst his/her students?

Will the District be providing teachers with CDC-approved PPE?

How about students who forget a mask? This should be added to the student dress-code. Just like wearing pants and a shirt to school, students must wear/bring a mask(s).

Can teachers wear scrubs? Experts recommend washing possibly contaminated clothing in warm/hot water and dry on high heat. This option would be helpful for staff while working under these conditions, so that we do not have to ruin our regular clothing.

What does full remote learning entail? Will there be pre-recorded lectures? Livestream lectures? Will these be daily or less often as they were the end of last year? Is there a required number of hours the teachers must interact live with the kids?

Will remote students be assigned teachers that only instruct remote kids? Or will the same teachers be instructing in-person and remote learners? Will teachers of remote students have more students to manage than in-person teachers? WIll teachers of remote students have more students to manage than prior, typical years?

Will remote learning students be taught the same curriculum as the in-person students?

I have a child in the G&T program at Lloyd and a child in advanced classes including Geometry in Middle School - will they get the same instruction and same teachers as their peers that choose in-person learning?

If I choose remote learning, and a vaccine is approved and released partway through the school year, can my children switch over to in-person?

If I choose remote learning, will my middle schooler be able to participate in Cross Country and Track IF those sports find a way to proceed in a safe way?

Will kids that go hybrid get actual teacher instruction on the 3 virtual days?

If I choose Hybrid but my children feel unsafe after starting in-person (for instance, fellow students not keeping masks on or teachers/students getting sick) can I switch them to remote?

What are the exact hours of the school day when learning in person? Same as half day?

Will virtual learning hours be flexible for children like my 10 year olds that need help here and there but have two parents that work full time 8:30-5:30?

The Covid tests are taking about 5 days to get back to people. At what point will a child or teacher be expected to quarantine themselves? Even if they quarenteen themselves once they know they have been around someone that tested positive and waiting for their own test to come back, they still could have exposed people. The minute someone finds out they have been exposed to someone with the virus that person

The minute someone finds out they have been exposed to someone with the virth the proven should not come to school until they test negative. In the mean time the students in the class should be notified so that they can have to choice to get tested too or self quarantine. Many students live with or visit high risk people and we need to be totally transparent with each other for this to be safe. If we are waiting for 5 days for a test to come back until we notify then during the 5 days there can be children. That expose many more because they did not know they possibly were exposed.

Here is an example that happed to us. My husbands secretary's husband tested positive. While she was waiting for his results she came to work and did not tell anyone that he was being tested. My husband was in the office working along with other people. My husband when to a friends house for his Birthday and there was 5 people there. Of those 5 people 3 of them had events to go to that had 20 people at. Lucky we found out her husband was positive and closed the office and got tested and told our friends as soon as we found out we Could have been exposed. While we waited for our results we selfquarentined and Our 5 friends from the birthday party did not go to their events. We were all negative, including his secretary so no Covid ever entered the office. But if we waited to get the test back from his secretary (5 days)to see if she was positive and were not transparent with our friends this could ended with us exposing over 100 people.

We do not want to expose people unknowingly while we wait Days for the testing to come back. Until the testing can be quicker we need to have students stay home if the Postentally have been exposed not just if they have been exposed by a positive test. We have to inform the students also if this Potential so the students and there family can decide if they should get tested and not visit high risk people. It is all about Transparency. Something that Needs to be done if this is going to work.

Is there a dedicated teacher for those who choose 100% virtual? Or will that teacher also be teaching in person?

Will the ones who attend 100% virtual just be watching live zooms?

If the students attend in person, will they be changing classes?

How many students to a class?

When will the classrooms be cleaned?

How will virtual be different than last year?

Last year, the teachers and their assignments for my junior were so varied and inconsistent. Sometimes the assignments would be due at midnight, sometime before the class even started (10am) and sometimes at 3pm. This was VERY stressful for my ADHD son. One teacher posted 3 weeks of assignments on the same day in Classroom so to distinguish one assignment from the other was very confusing for him and overwhelming. I tried to make sense of it and it was LUDICROUS. Some teachers used Google Forms to collect their assignments which was problematic because my son could not check to see if he had turned the assignment in. Some assignments showed up in Google Calendar, some did not. The teachers need to be as CONSISTENT as much as possible, especially for those who struggle with Executive Functioning Skills. Have things like this been thought of and planned for?

Lastly, math assignments need to involve paper and pencil.

As a teacher, will I be required to purchase specific PPE for teaching? For example, Specific masks, scrubs, gloves to protect ourselves when we return in Sept

Raffaela Donnelly:

Thank you all for your hard work and continuous effort to get our kids back in school. We truly appreciate the hard work that has gone into this. I am looking forward to having our children in school on a hybrid schedule.

My concern is related to the virtual lessons. I have had two different experiences with my children for the 19/20 school year. My son at Lloyd Road (he is now entering MAMs in September) had a great experience and had video conferences with his two teachers at least two times a week each. However, the grading at elementary level was pass or fail which I don't think was fair as the kids did not learn. Will there be actual grading this year? I am not sure how they were graded at the Middle School level but I'm hoping they will get actual grades this year.

My daughter on the other hand attends the high school and is in all honors classes. Her experience left a lot to be desired. Only her Italian teacher had video conferences each week. Each of her other teachers (again all honors courses) **did not have any** video conferences at all. She had no live instruction and instead was just given assignments which were then graded. Will there be a requirement for teachers to have live conferences with the children? I truly don't think the kids will learn or advance in their studies without live instruction while virtual. Anyone can push an assignment to them and grade it – they need the teacher to instruct and guide them on a regular basis. I understand that for 19/20 the school had to change courses so quickly and therefore I did not raise this previously and did not email the HS principal at the time. However as the schools have now been planning for this – I am hoping there are rules and requirements around virtual learning as well. I would love to hear more about this during the meeting.

I have a question concerning the full virtual learning option offered for students during the 2020/2021 school year. Will students that choose the full virtual learning option be permitted to take part in extracurricular activities, on school grounds, such as marching band and jazz band?

FAQ

1. If I enroll my child in Hybrid and then want to switch, can I?

- Yes at the end of the marking period, you can switch to All remote; the converse is also true, if you are enrolled all virtual and want to switch to hybrid you will be able to at the end of the marking period.

- 2. Will masks be required?
 - Yes, at all times pursuant to the Governor's Executive Order.
- 3. There is a concern wearing masks in heat.
 - All classrooms are air conditioned

4. Will children in All Remote receive the same education/course work as the Hybrid enrolled students?

- Yes, no matter who the child is enrolled the content of the education will be the same, ensuring equity is of importance to the district.

5. How will class work such as labs be done virtually?

- There are programs that have been created to simulate the labs and classwork. The district has purchased these programs.

6. How will this year virtual learning be different from last year, to solve for the inconsistency seen last year?

- Teachers will receive a week of professional development to supply tools and training to staff to support more Google meets and less work sheet work. The district maintains a goal of obtaining as close to synchronous teaching as possible. 7. Will classes be live streamed on in person days and times?

- The format is not completed at this time, the goal is synchronous teaching.

8. Will students in the hybrid model have the same teachers when they are virtual?

- Yes, however scheduling is not complete yet.

10. How will the district ensure accountability of the students/ will there be a schedule for them to follow?

- Using Google classroom?

11. Will there be office hours for both virtual and hybrid students?

12. Will assessments be done virtually? How?

13. How often will this plan be evaluated?

-The District plan will be reviewed a minimum of 4 times a year.

14. How will attendance be taken?

- The policy remains the same; the student will have to log into their class, failure to do so will result in an absence. If there is an issue the parent/guardian should email the building principal.

15. Will students' temperature be taken every morning?

- Every morning the parent will be required to complete a google form, which will require them to state their child's temperature. If that form is not received the student will not be allowed inside the building. NO student or faculty or staff will be allowed in the buildings with a temperature of 100.4 or greater.

16. How will cleaning occur?

- High touch points such as doorknobs bathrooms will be cleaned on a continual basis.

- Every room will be cleaned between classes and again at the end of the day. Deep cleaning will occur on Wednesday, as this is the day in between the two groups of students.

17. Passing periods, will students be switching classrooms (MAMS and MRHS)?

- Yes, they will be staggered to minimize contact.

18. Where will hand sanitizer be?

- Each classroom, bathroom, entrance to school, bus will have sanitizer.

19. What is the protocol when someone is in school and becomes symptomatic?

- That student would be placed in an isolation room that has been located in close proximity to an exit.

20. How will parents and staff be informed?

- The local Department of Health will be responsible for contact tracing. Good and accurate contact tracing is dependent of student, parent and faculty cooperation.

21. Will students who are Fully Remote be able to participate in after school sports and activities?

- Yes.
