4. Adoption of the 2018/19 Proposed Budget

The Superintendent recommends that the Matawan-Aberdeen Regional School District Board of Education approve the resolution pertaining to the approval of the 2018/19 budget as presented at the public hearing on April 30, 2018, as follows:

WHEREAS, the Matawan-Aberdeen Regional School District Board of Education adopted a tentative budget for the 2018/19 fiscal year on March 26, 2018, to be submitted to the Executive County Superintendent of Schools for approval; and

WHEREAS, the tentative budget was approved by the Executive County Superintendent of Schools on April 25, 2018; and

WHEREAS, the tentative budget was advertised in the legal section of the Asbury Park Press on April 27, 2018; and

WHEREAS, the budget was presented to the public during a public hearing on April 30, 2018; and

WHEREAS BE IT RESOLVED, that the Matawan-Aberdeen Regional School District Board of Education withdraws \$600,000 as budgeted in line 620, Budgeted Withdrawal from Capital Reserve – Excess Costs & Other Capital Projects, for other capital project costs of concrete, curbs and parking lots at Matawan Regional High School, Lloyd Road Elementary and Cliffwood Elementary Schools. The total cost of these projects is \$600,000, which represents expenditures for construction elements or projects that are in addition to the facilities efficiency standards determined by the Commissioner as necessary to achieve the New Jersey Student Learning Standards.

WHEREAS, the Matawan-Aberdeen Regional School District Board of Education requests the approval of a maintenance reserve withdrawal in the amount of \$800,000 for the purposes of funding the general fund maintenance accounts, 11-000-261-420 and 11-000-261-610; and

WHEREAS, the Matawan-Aberdeen Regional School District Board of Education requests the approval of an emergency reserve withdrawal in the amount of \$150,000 for the purposes of the purchase of a radio system to be used for security and communication purposes; and

WHEREAS, the Matawan-Aberdeen Regional School District Board of Education has the ability to exceed the 2% cap permitted on the general fund local tax levy increase for certain increases on the premiums for health insurance and through the use of health insurance banked cap to balance the 2018/19 budget; and

WHEREAS, the Matawan-Aberdeen Regional School District Board of Education has determined that \$519,716 is necessary in health insurance adjustment and \$506,978 is needed in health insurance waiver banked cap adjustment to balance the general fund for the 2018/19 fiscal year budget in order to maintain existing programs, implement mandated programs and remain in alignment with the district's goals and objectives for the upcoming fiscal year; and

BE IT RESOLVED, that the Matawan-Aberdeen Regional School District Board of Education approve the 2018/19 budget supported by a general fund local tax levy in the following amounts:

6. Resolution Authorizing Submission of an Additional Spending Proposal to the Legally Qualified Voters of the School District at the Annual School Election

BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE MATAWAN-ABERDEEN REGIONAL SCHOOL DISTRICT IN THE COUNTY OF MONMOUTH, NEW JERSEY AS FOLLOWS:

a. It is hereby determined that an additional spending proposal will be submitted for voter approval at the Annual School Election. The form of the proposal will read substantially as follows with such adjustments as provided by bond counsel in accordance with guidelines or requirements of the Department of Education:

PROPOSAL FOR ADDITIONAL FUNDS

Resolved, that there should be raised an additional \$400,000 for General Funds in the same school year (2018-19). The Board of Education recognizes that the need exists for additional security personnel in addition to the existing School Resource Officer currently provided to the district as a result of the shared service agreement with the Township of Aberdeen. The additional taxes will be used exclusively for the purposes of hiring up to seven Township of Aberdeen or Borough of Matawan police officers to provide additional security during normal school day hours in excess of the needs of a thorough and efficient education and the expenditures necessary to achieve the NJSLS. Approval of this tax proposal will result in a permanent increase in the district's tax levy.

The additional taxes, if authorized, will be used exclusively for the purposes described herein. The proposed additional expenditures are in addition to those necessary to achieve the New Jersey Student Learning Standards.

- **b.** This Board of Education hereby approves and adopts the proposal set forth above and, subject to the approval of the legal voters of the school district, hereby determines to carry out the purposes described therein.
- **c.** The Business Administrator/Board Secretary is hereby authorized and directed to send a certified copy of the proposal to the County Clerk as required by N.J.S.A. 19:60-2 and to request the County Clerk to arrange for it to be voted on at the Annual School Election.
- **d.** The Business Administrator/Board Secretary is hereby further authorized and directed to send a certified copy of the proposal to the Executive County Superintendent for approval as required by N.J.S.A. 18A:7F-5(d)(9), N.J.S.A. 18A:7F-39 and N.J.A.C. 6A:23A-12.13.
