If the Board feels it possesses a sufficient number of applications it will move forward with the process. He hopes there isn't a vacancy when Dr. O'Malley leaves. There will be an Executive Session to consider what the public stated.

VI. PUBLIC FORUM – CHARACTERISTICS OF NEW SUPERINTENDENT

- Inquired if the District was using an agency to hire the superintendent. Mr.
 Kenny stated as of now the Board will not be using an agency. The position has
 been advertised in the Star Ledger and also picked up on the internet. The Board
 could always change the process.
- Requested that the process remain open to the public. Its possible people didn't show today because it's the Monday after the long holiday weekend. Mr. Kenny stated although everyone is at this meeting informally, members of the public can speak at the Committee and Regular Action meetings. The email addresses of Board members are on the District website as well. Encourages members of the public to come forward and be heard because the Board wants the process to be transparent.
- Would like to see the Board have a forum where members of the public can ask
 potential candidates' questions and have the community get to know them. This
 has been done in the past for principals. Mr. Kenny stated the Board would
 consider it.

Pleased with the direction the Board and current superintendent is going. What
qualifications is the Board looking for in the new superintendent. Mr. Kenny
stated it will be based on the qualifications requested for in the advertisement.
They include but are not limited to a superintendent's license or certificate;

• Are there specific qualities in the person the Board is looking for? Mr. Kenny answered that's what the Board wanted to get from the public. As a Board they will not tell anybody what they're specifically looking for.

Laura Porter, 71 Juniper Place,

Three years ago the Board had a firm do the search for the superintendent. There
should still be documents that the Board can utilize for the current process. Mr.
Kenny stated the Board will look into that and will use what assets the Board has
from the past and build on it.

Ms. Kruzik, Cliffwood Beach,

 Would like to have a superintendent that has a vested interest in the community and will make a difference.

Ms. Robinson, 461 Sonia Avenue, Matawan,

- Is happy with what Dr. O'Malley did for the District and is pleased with the High School academies.
- Would like to hire a superintendent who is professional and not allow teachers to behave unprofessionally. The superintendent should be honorable and not hold the bar down to the ground for minority students. That person should also have knowledge of diversity.
- The superintendent should fix the problems at the High School, such as the SAT scores. Also would like someone who listens to what everyone has to say and acts upon it.

Mr. Kenny thanked everyone for coming to the meeting. Noted that the email addresses for the Board members are on the District website and looks forward to continuing this process.
