A Regular Meeting of the Board of Trustees of Aledo ISD was held Monday, October 15, 2018, beginning at 7:00 PM in the Aledo ISD Administration Board Room. Board members present were Hoyt Harris - President, Forrest Collins – Secretary, Julie Turner – Trustee, Jessica Brown – Trustee, Jennifer Loftin – Vice President, Bobby J Rigues – Trustee, and David Lear – Trustee.

- I. Call To Order
President, Hoyt Harris, called the meeting to order at 7:00 PM.
- II. President, Hoyt Harris, determined a Quorum was present at this time.
- III. Pledge of Allegiance to the United States and Texas Flags
Amy Sadler, Principal, Coder Elementary and students of Coder Elementary led the Pledge of Allegiance to the United States and Texas Flags
- IV. A moment of Silent Prayer or Reflection was held.
- V. Campus Presentation - Coder Elementary School
Amy Sadler, Principal, Coder Elementary, introduced Ms. Lasater who brought along several of her Science students who explained how Critical Writing helped them with their science experiments.
