

**Minutes of Regular Meeting  
The Board of Trustees  
Aledo ISD**

A Regular Meeting of the Board of Trustees of Aledo ISD was held Thursday, January 25, 2018, beginning at 5:30 PM in the Aledo ISD Administration Board Room.

I. Call to Order

President, Jay Stringer, called the meeting to order at 5:35 P.M. Board Members present were Forrest Collins, Julie Turner, Hoyt Harris, Jay Stringer and Jennifer Loftin.

II. President, Jay Stringer determined a quorum was present at this time.

III. Work Session

A. Bond Election Survey Results

VII. Superintendent Report

Dr. Derek City, Superintendent, announced upcoming district events such as the Jack Harvey Award on Friday (1/26) where Ms. Arlene Shelton would be receiving an award. Several members of Central Administration will be attending the Mid Winter Conference in Austin from 1/29/18 – 1/31/18. Brown bag lunches will be starting up. DCS Dissolution meetings are still taking place. January is School Board Recognition month. It is also Career Technology Education month. February 5-9 is Counsellor's Appreciation week. February 19-21 National Future Farmers of America Week.

The Aledo 'A' logo is now a Trademark Logo. We will continue to enforce infringement of the logo as it does add value to the District. Entities that use it without our permission are taking money from our District and students.

The United States Department of Education Ruling on Texas Special Education Services 8.5% limit of servicing Special Education Students was discussed. Dr. City, Superintendent, said the reality is that the number could be greater or smaller than 8.5%. He wants the community to know that Aledo ISD has never observed this limit. If students are tested and recognized as having a need they will be served.

Lynn McKinney, Deputy Superintendent, attended a City Council Meeting with the City of Aledo to represent the District to show our opposition of the Licensing of a Business, opposite McAnally Intermediate, to sell wine and beer.


