



## **Aledo ISD SHAC meeting minutes – April 29, 2024**

**I. Welcome** ~ Meeting began at 5:30 PM, 28 members were present including 25 voting members and 3 non-voting members. **III. Follow up on SHAC activities** ~

Discussion followed regarding ideas for future Parenting University ideas that will be presented in a podcast format that families could access on demand. Feedback was gathered and shared. Ideas presented included Executive Functioning; Forming good study habits; Navigating district learning platforms/programs; Sleep habits; Planning your post high school life (Just for Juniors style).
